## RPM's MAP Policy Agreement

Minimum Advertised Price (herein referred to as "MAP") Policy  
for Redline Performance Machines (herein referred to "RPM")

RPM's MAP Policy has been designed in order to help Dealers maintain long-term strength and equity of the RPM brand by engaging in advertising that best conveys to customers the value of RPM's products. This policy has been put in place to ensure that Dealers can profitably market and effectively promote the value of RPM products.

The Minimum Advertized Price for RPM products is defined as 5% below List Price. The List Price and the MAP price (discount price) can be found at [www.team-rpm.com](http://www.team-rpm.com) individually by product.

Dealer agrees not to suggest that prices lower than MAP are available in any advertisement (defined below) where MAP prices are shown. Dealer agrees they can establish any actual retail selling price they choose, providing that prices lower than MAP are not advertised or shown publicly in any media including the internet. Providing that price discussions between Buyers and the Dealer are private, no minimum price is enforced. Used products are not bound to MAP providing that they are clearly shown as "used".

"Advertisement" is defined as any and all advertisements in all media including, but not limited to, inserts, newspapers, magazines, catalogs, public signage, billboards, any other print media, television, radio, e-mail, internet websites or other ecommerce, flyers, posters, coupons, brochures, any use of hypertext transfer protocol or internal links to a web based shopping cart and any other electronic media.

Dealers found in violation of MAP will be restricted to Price Level 6. If violation continues Dealer status will be revoked.
