A duration of immunity of at least 10 weeks has been demonstrated against SIV type H3N2 and at least 25 weeks against *M. hyopneumoniae*. **Directions:** Shake diluent before use. Aseptically rehydrate the freeze-dried vaccine with the liquid bacterin provided, shake well, and administer 2 mL intramuscularly. Administer a single 2-mL dose to healthy swine, followed by a single dose of FluSure XP approximately 3 weeks later. In young pigs, vaccinate after maternally derived antibodies to SIV have declined. For advice on revaccination, contact your veterinarian or the manufacturer.

**Precautions:** Store at 2°-8°C. Prolonged exposure to higher temperatures and/or direct sunlight may adversely affect potency. Do not freeze. Use entire contents when first opened. Do not vaccinate within 21 days before slaughter. Contains gentamicin and thimerosal as preservatives. In case of allergic reaction, administer epinephrine. Do not mix with other products, except as specified above. In case of human exposure, contact a physician.
