This product has been shown to be effective for the vaccination of healthy horses 10 months of age or older against encephalomyelitis caused by Eastern and Western viruses, equine influenza due to type A2 viruses, and tetanus. Fluvac Innovator 4 contains equine influenza virus A/equine-2/Kentucky/97 (H3N8)-American Lineage. Field safety testing has demonstrated that this product is safe for use in horses 3 months of age or older. Efficacy has not been established in foals 3 months of age.

Efficacy has been demonstrated in 10-month-old horses by challenge with equine influenza virus A/equine-2/Ohio/03 (H3N8)-American Lineage.

Directions: Shake well. Aseptically administer 1 mL intramuscularly. Healthy horses should receive two doses administered 3-4 weeks apart. For advice on revaccination frequency or in the face of stress or exposure, contact your veterinarian or the manufacturer.

Precautions: Store at 2°-8°C. Prolonged exposure to higher temperatures and/or direct sunlight may adversely affect potency. Do not freeze. Use entire contents when first opened. Transient local reactions may occur at the injection site. Do not vaccinate within 21 days before slaughter. This product has not been tested in pregnant animals. Contains formalin, thimerosal, neomycin, and polymyxin B as preservatives. In case of allergic reaction, administer epinephrine. Do not mix with other products. In case of human exposure, contact a physician.
