Objectives:

The main objective for this report is to trace the Yocum family in order to confirm that Mary Loretta Yocum was the daughter of David Yocum, son of David Yocum. Additionally, verify the parentage of each David Yocum.

Background Information:

The client had provided a will, dated 18 June 1888, for David Yocum who bequeathed \$100 to his granddaughter, Loretta Yocum, when she became eighteen years old.

- David Yocum lived in Island Creek Township, Jefferson County, Ohio.
- Mary Yocum was David's widow.
- Children of David Yocum:
 - o Elias Yocum
 - o John D. Yocum
 - Stephen N. Yocum
 - o Cyrus M. Yocum
 - o Asa W. Yocum
 - Sarah Jane Still
- David named his son, Asa W. Yocum, as his executor.

The client also had a marriage record for Mary L. Yocum and George L. Gilbert.

- Client stated Mary L. was Mary Loretta Yocum who used each name on varying documents.
- They were married 2 August 1915 in Cuyahoga County, Ohio.
- Mary was 40 years old, making her birth possibly 1875 in Steubenville, Ohio.
- Her parents were David Yocum and Josephine Kelly.
- She had previously been married once to Mr. Wood, but was divorced in Columbiana County, Ohio.

Analysis:

Mary's previous marriage to Mr. Wood might provide further details concerning her parents as well as more about Mary Loretta.

Mary used the name, Retta J. Yocum, when she married Thomas N. Wood on 17 May 1904 in Steubenville, Jefferson County, Ohio. Retta could be a nickname for Loretta. She was 29 years old, meaning her birth was about 1875 in Steubenville, Jefferson County, Ohio. Her parents were David L. Yocum and Josie Kelly, which relatively matched the details from the marriage record to George Gilbert.

Another change besides Mary's name, was the acknowledgement of another marriage to Frank R. Cole, which ended in divorce.¹

Frank R. Cole married Miss Retta J. Yocum on 30 September 1891 in Steubenville, Jefferson County, Ohio. Retta was 17 years old, making her estimated birth about 1874.³

Searched Jefferson County, Ohio Birth records, 1867-1908 collection at FamilySearch https://www.familysearch.org/search/collection/1932106 for Mary Loretta's birth by:

- searching for her name variants,
- searching for any child with David Yocum as the father, and
- browsing the "Y" index for volume 1, 1867-1879.

We could not locate a birth record for Mary Loretta.

Was Joanna, who was on the 1850 Census, and Josephine "Josie" Kelly, named on Mary's marriage records, the same woman?

David L. Yocum married Joanna Kelley on 2 July 1872 in Jefferson County, Ohio.⁷ The use of the same surname indicates that Joanna and Josephine are the same person.

What happened to Mary Loretta's parents?

Neither of Loretta's parents were mentioned in her grandfather, David Yocum's probate documents, including the Will, Administrator Docket, and Estate Inventory, which were documented in the Probate Court until his estate was settled 6 September 1895. Loretta would have been approximately 13 to 14 years old at the time his will was probated in 1888 so where are her parents, given that she was to inherit \$100.

David, Loretta's father, died of consumption at 34 years old, on either 1 or 12 May 1884 in Island Creek, Jefferson County, Ohio.9

Johanna, Loretta's mother, died at the age of 36, on 7 March 1888 in Steubenville, Jefferson County, Ohio. Her death was accidental, she was burned.¹²



With Loretta being a minor and an heir to an inheritance, a guardian needed to be appointed by Probate Court.

Stephen E. Yocum, Loretta's uncle, was named the "Guardian to the Estate of Retta J. Yocum, a minor child of David L. and Joanna Yocum, deceased" on 30 September 1891. Mrs. Retta J. Yocum Cole received her inheritance of \$100 on 26 January 1893. 16



David Yocum married Mary Hottle on 12 August 1841 in Jefferson County, Ohio.¹⁸





David Yocum died at 66 years old from consumption on 16 July 1888 in Island Creek Township, Jefferson County, Ohio.²¹ David's parents were documented as John Yocum and Sarah Davis.²²

John Yocum's Will was probated 12 January 1866 in Jefferson County, Ohio with the following family members named:²⁶

"I will and bequeath to my beloved wife Sarah the farm on which I now reside in Steubenville Township Jefferson County, Ohio, during her natural life. She to have the proceeds, and income of said farm, and at her death it is my will that said farm be sold, at the most advantageous manner and the proceeds,




divided equally, among my children ten in number, to wit, David Yocum, Phillip Yocum, Mary Moreland wife of Joseph Moreland, Jane Priest wife of Allen Priest, and her heirs, Hanna Priest wife of John Priest, Sarah Buchanan wife of Westley Buchanan, John Yocum, Elizabeth Yocum, Louisa Yocum, and Silas Yocum except David Yocum, and Mary Moreland who are each to receive one hundred dollars less than the other eight, they having each received already one hundred dollars."
