

Battery Heat Shield - Side Post

Installation Guide




The PPE Battery Heat Shield - Side Post version can be installed on your already installed battery or before the battery is installed. The steps are similar.

The following instructions are for a battery that is already installed. Because of the universal application and some potential clearance restrictions, installing the PPE Battery Heat Shield before the battery is installed can be easier and make for a tighter fit.

Installation:

- Step 1. Vehicle off. Engine cool.
- Step 2. Access battery. Disconnect bracket that secures battery. Disconnect negative terminal cable then disconnect positive terminal cable. Check your cables. Replace if worn. Clean battery surface.
- Step 3. Open Heat Shield flap. Orient Battery Heat Shield so terminals protrude through the Shield openings.



- Step 4. Wrap Heat shield around battery, pull until snug and engage the hook and loop material to create a tight fit.
- Step 5. Connect positive terminal cable then connect negative terminal cable.

 Lower protective flap and engage hook and loop material to secure.
- Step 6. Check clearance. Reinstall bracket to secure battery.

Installation complete.
