

**Hodgetwins #11 Sweepstakes  
Official Rules**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.**

1. **Eligibility:** The Hodgetwins #11 Sweepstakes (the "Promotion") is open only to legal residents of the 48 contiguous United States and the District of Columbia (excluding New York, Florida, Alaska and Hawaii) (the "Territory") who have reached the legal age of majority in their state of residence and are located in the Territory at the time of entry.
