

### RAPTOR ALERT<sup>™</sup> RAS-000-09

This fall warning system activates in the event of a fall. Emitting 130 decibles with a siren and strobe light, a fall cannot go unnoticed even on the loudest jobsites.

## RAPTOR RESCUE

In the event of a fall, a prompt rescue is required. The Raptor Rescue system attaches to the center beam of the mobile fall cart and features a 5-1 gear reduction wench system. The rescue pole can be extended up to 12 ft.









## **Frequently Asked Questions**



#### WHERE ARE THE COUNTERWEIGHTS AND/OR WATER TANKS?

The Stinger<sup>™</sup> uses 12 removeable counterweights. This allows for the added convenience of moving the unit. The Stinger<sup>™</sup> will fit in the bed of a truck, through doorways, in elevators and through roof hatches.



#### **HOW DOES IT WORK?**

If a fall were to occur, the Stinger<sup>TM</sup> has a patented roof safety engagement device which penetrates the roof. This creates a secure anchor point to arrest the fall.



#### HOW MANY MEN CAN ATTACH TO THE STINGER™?

One man can attach to the Stinger<sup>™</sup> for fall arrest protection. One additional man can attach to the Stinger<sup>™</sup> for fall restraint for a total of two men attached at any one time.



#### IS THE STINGER<sup>™</sup> OSHA APPROVED?

The Stinger<sup>™</sup> is manufactured in compliance with OSHA regulation 1926.502(d) for fall arrest anchors.

#### WHERE DO I HOOK UP TO ON THE STINGER™?

One ring is welded to a green plate located in the center on the side of the Stinger<sup>TM</sup>. This is the fall arrest tie-off point. One yellow swiveling d-ring hook is the tie-off for fall restraint.



#### CAN THE RAPTOR RESCUE<sup>™</sup> BE USED WITH THE STINGER<sup>™</sup>?

Yes-the Raptor Rescue wench and pole retreival system can be used to rescue a fallen worker.



#### WHAT TYPE OF TIRES ARE INSTALLED ON THE TRIREX™?

All Stinger<sup>M</sup> models come standard with solid polyurethane tires.

## ARE THERE ANY PARTS THAT NEED TO BE REPLACED OR RECERTIFIED AFTER FALL ARREST?

Although the Stinger<sup>™</sup> can be used again after a fall arrest, it's a good idea to replace the claw components. We've got you covered with our Piviot Point Replacement Kit.

The **<u>Pivot Point Replacement Kit</u>** contains a new pivot pin, brass bushings and a washer and cotter pin.



#### HOW MUCH DOES THE STINGER<sup>™</sup> AND IT'S WEIGHTS WEIGH?

The frame weight of the base model Stinger<sup>™</sup> with solid tires weighs 126lbs. Each of the 12 counterweights weighs 50 LBS.



#### CAN I INSTALL MY OWN EQUIPMENT ON THE STINGER™?

Yes-Leading Edge Safety offers the optional Raptor Rescue™ system, but the base model is sold without any additional equipment. The owner has the opportunity to install their own equipment.
