

MGP 30

Acid cleaner for building site dirt

Acid cleaner for saltpeter, cement and grouting residual on floors and coatings of natural stone, marble, granite and gres.



Coverage: 1 litre for approx. 10-100 m² depending on the finish of the surface and on the dirt.

Strong Points

- Water dilutable concentrate
- Solvent free
- Buffered acid
- Does not produce harmful fumes
- Can be sucked up and used with machines
- Effective also on resinous grouting
- Excellent on porcelain stoneware (gres): cleans and revives the original color and shine
- Suitable for rough surfaces (not for slate)

Application

SHAKE BEFORE USING

It is an aggressive and corrosive product, so do not use it on polished marble. DO NOT use pure.

Dilution: - light dirt: 1 litre of MGP 30 in 8-10 litres of water.

- heavy dirt: 1 litre of MGP 30 in 4-5 litres of water.

Manual cleaning: Make the surface wet and pour the solution directly on the floor, allow to act for approx. 5 minutes, rub with a scrubbing brush, suck up the dirt with a water vacuum, rinse out with water. Do not allow MGP 30 to dry on the surface, since it could leave undesired marks.

Cleaning with machines: Make the surface wet and pour the solution directly on the floor, allow to act approx. 5 minutes, rub with a cleaning machine using suitable discs, suck up the dirt with a water vacuum, rinse out with water. Do not allow MGP 30 to dry on the surface, since it could leave undesired marks. On very rough surfaces like bushhammered, flamed etc. the use of a brush is recommended.
