

## Protector for polished surfaces.

## Application

### SHAKE BEFORE USING

READY TO USE PRODUCT, DO NOT DILUTE.

On clean and dry surfaces or still wet but after water vacuuming apply MGT 27K directly onto the surface and spread it out evenly with a microfiber cloth with circular motions. In case of very absorbing surfaces apply 2 consecutive coats.

After drying the surface will be protected and no residues or colour changes will be noted. On poorly absorbing marble or granite, the product can leave some light residues, which can be removed with a cloth or a floor polisher.

Wait at least 48/72 hours before carrying out staining tests, so to allow the product to dry in the porosity of the surface.

It does not protect marble against acid substances that can cause a slight corrosion.

For the ordinary maintenance of the treated surface we recommend the regular use of MGP 24 detergent.

## Warnings

## Packaging and Storage

Keep the original, sealed container in covered, ventilated, dry environment and keep away from heat or low temperatures. After the use keep the package well closed, so the product has a shelf life of approx. 36 months. Box of 15 x 1 litre bottle – Box of 4 x 5 liter cans
