

LIMITED WARRANTIES

In the interest of purchaser peace of mind, the quality of our equipment, parts, and components are backed up by the strength of our Warranties.

Below is a complete overview of these warranties. In the event any product is defective or you need technical assistance, please contact our customer service team Monday through Friday from 9:00 am to 5:00 pm EST.

Kegnado[™] and its components are warrantied exclusively by Atlas Diversified Products Corporation (ADPC) that its products will be free from defects in material and workmanship, under normal use and regular service, and preventative maintenance for the Warranty Period (defined below).

60 DAY LIMITED WARRANTY

ADPC will accept returns during the initial 60 day warranty period for the Customer's FIRST purchase of Kegnado[™], limited to 5 Units, for any reason, barring returns due to accidental damage, alteration, misuse or abuse. During this 60 day unconditional warranty period, the customer will have the option to either return Product for full refund of purchase price, or replacement of the Product.

Authorization is required for any Product Return. Contact ADPC for a Return Authorization number; describe the items being returned and the reason. All Product Returns must be shipped back to ADPC within fifteen (15) days of receiving the Return Authorization Number. Products must include the original packaging, documentation, manuals, and accessories.

ADPC is not responsible for returned shipments that are lost, pilfered, or damaged.

Refund will be issued after ADPC has received the Returned Product.

1 YEAR LIMITED MANUFACTURER'S WARRANTY

Unless otherwise specified, ADPC will accept returns for the remaining year of the standard warranty period for all products that have defects in materials or workmanship, or failures during normal use subject to the terms and conditions listed below. This Warranty is limited to 90 days (from original purchase) for parts subject to normal wear and tear (o-rings, seals, etc). Some products not made by ADPC (such as the Keg and the cleaning brush) are warrantied by their respective manufacturer; therefore, this Limited Warranty does not apply to such products.

The Customer pays for the cost of shipping of all approved warrantied products back to ADPC. Insure all packages. ADPC is not responsible for returned shipments that are lost, pilfered, or damaged.

If any defect is discovered in the product during the Warranty Period, the purchaser must notify ADPC's customer service department to obtain a return authorization number and further instructions on how to return the product for service. Purchaser must follow ADPC's instructions.

ADPC will have no responsibility to honor claims received after the date the applicable Warranty Period expires.

TERMS & CONDITIONS

ADPC reserves the right to request proof of purchase (either in the installation note or invoice copy, etc.) with date of purchase showing model and serial number before accepting any liability for warranty claim.

ADPC's sole obligation under the warranty shall be to replace the defective product with a working one or a similar model of equivalent value if the same model is not available, in the occurrence of any failure or defect covered under the warranty during the warranty period. The warranty is provided only on device and not on other in-box contents such as batteries, cables, accessories, plastic consumables etc.

After receipt of a Kegnado[™] that ADPC determines is defective, ADPC will replace the defective component. ADPC's determination of defects is final. Failure by the Purchaser to give notice of claims of breach of warranty within the Warranty Period shall be deemed an absolute and unconditional waiver of the purchaser's claim for such defects. Products replaced during the Warranty Period shall be covered by the foregoing warranties for the remainder of the original Warranty Period.

If ADPC determines that the replacement is not covered under the warranty, you will be duly notified.

ALL REPAIRS MUST BE FIRST AUTHORIZED BY ADPC VIA THE ABOVE PROCEDURE. UNAUTHORIZED REPAIRS WILL NOT BE REIMBURSED BY ADPC UNDER ANY CIRCUMSTANCES.

ADPC is not responsible for parts damaged from factors including, but not limited to any part that has been subject to misuse, neglect, alteration, accident, unauthorized service, abuse, or any damage caused by transportation. This Warranty is limited to 90 days (from original purchase) for parts subject to normal wear and tear (o-rings, seals, etc). TO THE MAXIMUM EXTENT PERMITTED BY LAW, THIS WARRANTY, AND THE REMEDIES SET FORTH ABOVE ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, REMEDIES AND CONDITIONS, WHETHER ORAL OR WRITTEN, EXPRESS OR IMPLIED. ADPC SPECIFICALLY DISCLAIMS ANY AND ALL IMPLIED WARRANTIES, INCLUDING, WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT. IF ADPC CANNOT LAWFULLY DISCLAIM OR EXCLUDE IMPLIED WARRANTIES UNDER APPLICABLE LAW, THEN TO THE EXTENT POSSIBLE ANY CLAIMS UNDER SUCH IMPLIED WARRANTIES SHALL EXPIRE ON EXPIRATION OF THE WARRANTY PERIOD. NO ADPC RESELLER, AGENT, OR EMPLOYEE IS AUTHORIZED TO MAKE ANY MODIFICATION, EXTENSION, OR ADDITION TO THIS WARRANTY. To the maximum extent permitted by law, ADPC's liability hereunder, in any case, is expressly limited, at ADPC's election, to repair or replacement of the Product. Except as expressly provided in this Agreement, Purchaser assumes all other responsibility for any loss, damage, or injury to persons or property arising out of, connected with, or resulting from the use of Products, either alone or in combination with other products or components. To the maximum extent permitted by law, ADPC is not responsible for, and the purchaser releases ADPC from, direct, special, incidental, consequential, or punitive damages consequential damages resulting from any breach of warranty or condition, or related in any way to the equipment, or under any other legal or equitable theory, including without limitation loss of beverage, loss of gas or loss of sales. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This Warranty gives you specific legal rights, and you may also have other rights that vary from state to state.

ADPC will not pay for: Repairs or Replacement where use and/or damage resulted from accident, alteration, transportation, misuse or abuse.

This warranty extends only to the original purchaser and is non-transferable.

KEGNADO™ Limited Warranties

ADPC may assign any of its rights and/or obligations, either in whole or in part, to any of its affiliates or any third party. ADPC may also at its discretion enter into any subcontract with any person for the performance of any part of this warranty or appoint any authorized service provider.

Warranty is automatically terminated after the expiry of warranty period specified in this document whether or not product has been in use.

The warranty shall be void if product or part label/serial number has been removed, damaged, altered, or obscured.

The warranty does not cover failure or defects of the product or part has been resulted from or attributable to:

- Modification, service, maintenance or repair done other than by an ADPC representative or ADPC authorized partner.
- Any extrinsic cause, accidental damage, improper use, modification, adaptation, neglect, wear and tear, improper installation and connection external electrical fault leading to hardware/ component failure/ burnt and any fire accidents, which damage the hardware and the components.
- Operation outside the usage parameters stated in the user documentation.
- Improper physical/electrical or operating environment.
- Loss or damage in transit.
- Unauthorized correction alterations made in invoice copy/installation note.
- Default in the payment of full price of the product supplied by ADPC or its authorized reseller.

Other Warranties Disclaimed

These are the sole and exclusive warranties and conditions given by ADPC with respect to the products and services and are in lieu of and exclude all other warranties or conditions, express or implied, arising by operation of law or otherwise, including without limitation, warranties of merchantability, fitness for a particular purpose and non-infringement, whether or not the purpose of use has been disclosed to ADPC in specifications, drawings or otherwise, and whether or not ADPC's products are specifically designed and/or manufactured by ADPC for purchaser's use or purpose.

Limitation of Remedy

Purchaser's sole and exclusive remedy for breach of any warranty shall be limited to the repair, correction, or replacement, of the defective Products.
