

**Application:** General purpose weighing.

<u>Identification</u>: The required information is located on a metal plate riveted to the side of the scale and adjacent to the face of the device.

**Sealing:** The scale can be sealed by using a wire seal threaded through two brass screw heads on the bottom of the scale, which secures a cover plate preventing access to the calibration switch.

<u>Test Conditions</u>: The emphasis of this evaluation was on the device design, operation and compliance with influence factors requirements. For purposes of this evaluation two devices were submitted. A 30/60 lb x 0.01/0.02 lb, 15/30 kg x 0.005/0.01 kg and a 3/6 lb x 0.001/0.002 lb, 1.5/3 kg x 0.0005/0.001 kg were evaluated. Both of these devices were tested over a temperature range of -10°C to 40°C (14°F to 104°F). A load of approximately one-half capacity was applied to the scales over 100,000 times. The devices were periodically tested utilizing increasing/decreasing load tests and shift tests. Additionally, tests were conducted using 100 VAC and 130 VAC. CAS model DLP-50 printer was supplied and used for the purpose of this evaluation.
