- We like to protect our current customers and ensure that there is minimal cross over so that they can best sell our products. We will need to ensure your location does not clash with any of our current stockists.

WHOLESALE AND TRADE TERMS OF SALE

MINIMUM QUANTITIES

No minimum order. Payment for first orders are due prior to the dispatch of goods.

SHIPPING AND HANDLING

Freight charges apply to all wholesale orders of Peggy Press products. An order processing and handling fee of \$15 per order applies. These are in addition to the product prices.

For international orders, your freight quote may vary and additional cost incurred before your order is shipped.

We do not profiteer from order handling and freight charges. All charges in regard to shipping, order processing and handling are intended to cover the cost of fulfilling and delivering your order. Peggy Press continuously reviews the practices on how these costs can be kept to a minimum. We do our best to estimate shipping charges as accurate as possible when an exact cost is unavailable at the time of your order.



RETURNS & CANCELLATIONS

Return of faulty/broken items should occur within 5 days of receiving them. To report a broken item, please email the details of the damage and an image to hello@peggypress.com.au, and quote your invoice number. Non-delivery must be reported immediately.

All orders are final and cannot be cancelled once the order has been confirmed and the final invoice has been generated. We do not accept return of unsold goods or change of mind.

ORDER DISPATCH

We endeavour process your order within 24 hours and ship your order out as soon as possible. Please allow up to 2-3 weeks for processing and shipping.

PRICES

We reserve the right to alter our pricing at any time, unless already invoiced. The RRP for each product is listed on our main website (peggypress.com.au) and on our price lists. Stockists are free to set your own pricing as you see fit, but we ask that the products do not retail under the set RRP, unless they are clearly marked as being on sale. We kindly request that new collections are not sold below the RRP.

DISTRIBUTION

Peggy Press products may not be distributed through any physical or online marketplaces, including eBay, Etsy etc. Selling Peggy Press products on these marketplaces breaches our distribution policy and is not allowed under any circumstance.

PAYMENT TERMS

We currently do not offer net terms.

We accept VISA, MasterCard PayPal or bank transfer. Please state your invoice number as the payment reference when paying via bank transfer.

As we are a small business, we ask that invoices are paid in full prior to the dispatch of stock.

OVERDUE ACCOUNTS

All goods supplied remain the property of Peggy Press until payment is made in full. If we have your credit card details on file, we reserve the right to automatically charge your card the overdue amount. Any accounts that are outstanding for over 60 days may be passed on to debt collection and any fees involved in recovering the debt is the responsibility of the stockist.

Estimated delivery dates are approximate and for guidance only. We try our best to get your order dispatched to you as soon as possible, but we are sometimes affected by delays outside our control. Pre-orders are considered final orders and cannot be cancelled once paid.

We reserve the right to cancel the production of the products in our range. If this occurs, the payment received for the cancelled product will be refunded in full to the stockist.
