DVS General Conditions of Approval

- 1 The date and number of this import permit, the name of the importer, the vessel carrying the live animal & birds, pet animal, meat and meat products, frozen/chilled/canned meat & other products and the quantity shipped must be stated on the Veterinary Certificate by the issuing authority.
- 2 The consignment must be accompanied by the original Government Veterinary Certificate certifying all the import permit conditions.
- 3 This permit is issued in respect of one shipment only. For further consignments, fresh permits are required.
- 4 If the Veterinary Certificate does not conform to the conditions laid down in this permit, landing of live animal & birds, pet animal, meat and meat products, frozen/chilled/canned meat & other products will not be allowed.
- 5 This permit may be cancelled without any compensation at any time in case of disease outbreak or suspicion of disease in the country of export.
- 6 Arrival of each consignment should be notified to the Division of Veterinary Services at least two days before arrival.

SPECIFIC IMPORT CONDITIONS

HONEY

The consignment should be accompanied by the original of the International Veterinary Certificate issued by the Official Veterinary Services of the exporting country certifying the following:

PART A: ANIMAL HEALTH ATTESTATION

1. The exporting country is free from OIE listed diseases for bees or the honey originates from apiaries situated in a zone free from OIE listed diseases for bees.

PART B: VETERINARY PUBLIC HEALTH ATTESTATION

1. The honey originates from an establishment which has been approved by the Veterinary Authorities of the exporting country for the harvesting, processing, packing and labeling of honey for export. (Name and approval number to be stated in the International Veterinary Certificate)
2. The honey has been processed to remove all impurities.
3. The consignment is accompanied with results of laboratory analysis with regards to moistures, ash, acidity, apparent reducing sugars, apparent sucrose and water-insoluble matter.
4. The honey does not contain prohibited substances and residues of veterinary medicinal products in excess of MRLs in accordance with the recommendations of the latest version of the Codex Alimentarius.
5. The date and number of this import permit must be shown on the International Veterinary Certificate.

NOTE TO THE IMPORTER

- a) If the International Veterinary Certificate does not comply with the conditions laid down in this Import Permit, landing of the products will not be allowed.
- b) This permit is issued in respect of one shipment only. For further shipments, an application for an import permit should be made to the Livestock and Veterinary Division.

c) **This permit shall be cancelled without any compensation at any time in case of disease outbreak or suspicion of disease or veterinary public health issues in the country of export or in the country where the raw material originates or in the country where the products have been processed. In the event that the Import Permit is cancelled, importation of the products shall not be allowed even though the consignment may have left the country of export.**

d) The International Veterinary Certificate should be issued prior to the consignment leaving the country of export and the consignment should leave the country of export within the validity period of the permit.

e) The following should be written on each carton and/or on individual package: -

- (i) The name of packer/manufacturer
- (ii) The date of production
- (iii) The expiry date

f) Samples of the honey may be taken by the Livestock and Veterinary Division at time of arrival or during storage for analysis as part of its Official Sampling Programme.

g) Arrival of every consignment should be notified to the Livestock and Veterinary Division at least two days before arrival by filling in the Veterinary Entry Document in two copies and submitting it to the Livestock and Veterinary Division.

h) This honey should not be fed to honey bees. It should be meant only for human consumption.

i) The honey should be stored in approved warehouse.
