PRESIDENT'S REPORT

Welcome to the 2019 Annual General Meeting of the Highett Neighbourhood Community House and, following this, the Annual General Meeting of the Hampton Community Centre. The AGM provides us with an opportunity to look back and reflect on the activities of the House and evaluate whether those activities have focussed on the achievement of our vision, "To be known for providing innovative activities and events that connect & foster inclusive relationships across all ages, cultures & abilities and for connecting and fostering transformative leadership across all members of the local community".

Once again, many exciting activities were undertaken in 2018 to cater for the diverse range of needs of the local Highett community. Art Exhibitions, the Photography Competition, Highett Hub Livingston Street Party and an inaugural Highett Higher Ground Music Festival – a collaboration with Highett Village traders including the Highett Community Bendigo Bank. Our outreach work continues to grow on the Dunkley and Ludstone St Estates, meanwhile the business as usual activities of exercise and creative arts classes, play groups delivered across a range of ages and ethnic groups, continue. Through 2019 we will be focussing on building relationships in the community which provide the opportunity to identify, support and nurture new and emerging leaders. That focus will include providing opportunities for personal and leadership development of the HNCH and HCC teams.

The Board membership has been stable at eight members and we are sad to say goodbye to our Treasurer of two years – Lisa Stoneham. Recruitment of extra board members is being undertaken with a view to our Board being representative of the diversity of the local community. We have just completed our Strategic Plan for 2019/22 and Management has already been developing the operational plan that will underpin it. In 2019, the Board of HNCH will continue to support Hampton Community Centre in the delivery of governance and operational oversight until 31st December 2019.

Our management team across the two centres, Melanie supported by Kate, has continued to provide excellent leadership in the House and to maintain very strong relationships with many local stakeholders – the other residents of the Hub, retailers, associations and state and municipal government representatives. We have continued to extend our reach into the community through Erica's outreach and subsequently continued to increase staff effort where necessary to support that growth.

For yet another year, I acknowledge Jo and the volunteers who are the face of HNCH and manage relationships within the house kindly and effortlessly. The same thanks must go to Angie and Helen at HCC – the approachability of the first contact is essential for that sense of inclusion which is the basis of our vision. We appreciate your loyalty and continued commitment to the work of the House.

I also thank all the tutors and volunteers for their contributions to the work of the Centre and the focus on making it a happy, inclusive environment. That environment is enhanced by the respectful, cooperative relationships we have with our co-tenants at Highett, the Highett Senior Citizens, and the Greek Senior Citizens.

2019 promises to be yet another exciting year of both consolidation of current programmes and projects and the introduction of new directions reflective of our Strategic Plan.

TREASURER'S REPORT



My name is Lisa Stoneham. I was the Treasurer of the House from my election onto the Board two years ago at the 2017 AGM until my resignation in December 2018.

It is with great pleasure that I present the Treasurer's report for 2018. This report covers the period from 1st January to 31 December 2018.

Current practices have the accounts and financial transactions entered by an external bookkeeper. The house has been using the services of Narelle Davis from Davis Management Services to complete all bookkeeping work. Regular reporting is completed on a monthly basis by myself and is presented to the board.

An external auditor audits the finances every second year. Ryk Eksteen from Collins & Co carried out the most recent audit in January 2018. These practices protect the integrity of the finances in that they are being managed correctly and in a responsible way. This ensures the House has sufficient cash resources to deliver programs and any financial reports are a true and accurate reflection of the financial performance of the House.

I am very pleased to report an operating deficit of \$17,281 that compares very favourably against a budgeted deficit of \$37,651. Income earned exceeded budget by an impressive 23%. This is mainly due to the massive success of the community events held during the year such as the Higher Ground Festival and Street Party and higher than expected demand for the hire of our fantastic facilities. Our popular exercise and craft classes continue to perform well and we were also fortunate to receive additional grants from the Bayside City Council and Highett Community Bendigo Bank.

At 31 December 2018 the House had cash resources of \$165,153, which is more than sufficient to not only fund exciting new programs for 2019 but to also ensure the future financial sustainability of the House over the next few years.

I would like to acknowledge the continuing support of the Department of Health and Human Services, Bayside City Council and Highett Community Bendigo Bank in providing funding to the House.

I would like to thank Melanie Tighe and my fellow board members for their support and guidance over the last two years. It has been a privilege to serve on this board and to see the house go from strength to strength.

MANAGER'S

This year we hit the ground running with new staff, new ideas, new events and the big one, a new centre to oversee, Hampton Community Centre.

As mentioned in the President's report we delivered a number of new events such as Higher Ground, the Bayside Literary Festival and Lion's Den. The razzle dazzle of the one off events allowed us to successfully engage harder to reach audiences such as Millennials, Bayside Bookworms and Highett Hipsters with approximately 1,200 people attending the above events. All the while we delivered day to day activities and classes within the House to over 200 people a week.

This year we expanded our involvement on the Fox Dunkley Estate to include not only the Breakfast and After School Club but also a school holiday program and adult art classes. We thank Johnathan Nathan, who generously donated the proceeds of the sale of his art exhibition paintings to further fund the outreach work we undertake on the public housing estate, and Bayside Council for a one off grant.

A few notable achievements this year

- Secured major ongoing financial sponsorship from Highett Community Bendigo Bank
- 40% increase in Venue Hire income
- Hosting monthly radio program on Southern FM 88.3
- Collaborated with Libraries to introduce Highett as a drop off/reservation point

In 2018 we strengthened our ties with Bayside Council, successfully teaming up with Youth Services, Libraries, Healthy Ageing and Sustainability Departments to deliver activities and events. Networking with local organisations, including Connect Health, Bayciss, Castlefield Community Centre, Task Force, Rotary (Beaumaris, Hampton, North Brighton, Brighton), Kingston Council and Family Life, have offered us a chance to collaborate and create lasting partnerships to deliver support and services in our local area.

On to staffing, Jo James, our Office Manager extraordinnaire, continued to provide the calm, stable base which has enabled much of our growth this year. The support she gave was underpinned by the work of our loyal weekly volunteers, Heather, Julie, Mark, Silvia and Teresa.

The outreach and growth of the House events was driven by Kate Knight, Events Co-ordinator and Erica Breedon, Outreach Officer. Between the two of them they have increased stakeholder engagement, and created relevant (& enjoyable) events for our community.

Mikaela Copland, our Social Media Co-ordinator moved onto an intern positon (& we wish her every success) and Callen Neasmith has ably stepped into the role.

The HNCH Board is made up of committed and passionate local residents. I thank them for the support and strategic guidance they provide, in particular Marlene Johnson for her timely and sage advice. Thank you to our major funding bodies, Emma Cross from Dept of Health and Human Services and Jacqui Goy and Lauren Waycott from Bayside City Council. Cath and Wendy from Community House Network Southern also deserve a shout out.
