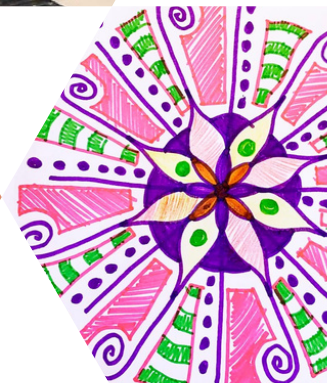
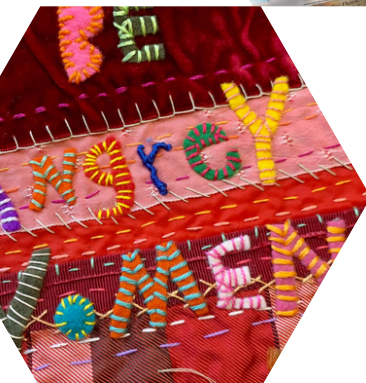

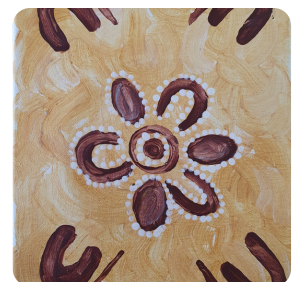

# PRESIDENT'S REPORT

Welcome to the 2022 Annual General Meeting for the Highett Neighbourhood Community House and the Annual General Meeting for Hampton Community Centre.

The AGM provides an opportunity for us to look back and reflect on the activities of both Centres and evaluate whether they are achieving our vision of promoting inclusivity across all ages, cultures and abilities and fostering transformative leadership in our local community. Like the previous year, 2021 was difficult with numerous lockdowns bringing imposed restrictions and ensuring we had a Covid safe plan to meet the everchanging legislated requirements.

This year, in particular, the innovative ideas, implemented by Melanie and the team have guided us through the challenges of Covid lockdowns, to ensure we can still reach our members beyond the bricks and mortar operating model, to a progressive new online hybrid model. We are very proud of this achievement! Well done to Melanie and the teams at Highett and Hampton in meeting these challenges and ensuring our services and activities remained available for the community, during such anxious times. Ramping up our meal delivery program sponsored by Cheltenham Rotary was a service greatly appreciated in the community during this period, as was the telehealth counselling on offer. The Government stimulus payments covered some staff costs, and also increasing the number of online classes, got us through this tough time.

We cancelled some activities in 2021 such as our annual Higher Ground Music Festival and many of our programs were delivered 'virtually', whilst the outreach work was extended to include catering for the vulnerable. Activities we hosted nurturing inclusive community relationships and respecting diversity included the Photography Competition, RUOK Day, the Chatty Café, LBGQTIA+ Chatty Cafe, the Nourish program and the Social Prescription pilot, which was a first in the neighbourhood sector. Our outreach programs will continue to be a major focus of our work. The business-as-usual activities such as creative arts, exercise classes and playgroups were delivered through the hybrid model of face-to-face or online as needed.

We remained committed to implementing our Strategic Plan. The focus of developing transformative leadership has been in ensuring that our systems, processes and staff are up-skilled and modelling and demonstrating leadership that inspires and empowers others. As such the staff and board have attended a range of professional development including gender identity training, strategic planning training, and other online workshops throughout the year. As such we have been acknowledged by Neighbourhood House Victoria for our leading-edge thinking and work. We have become a member of the Network of Bayside Community Centres and will be partnering with other centres to grow ours and their capacities. We have also been a voice of strategic thinking and reason on various upcoming building developments (e.g. Hampton and CSIRO sites)

I would like to acknowledge the staff's hard work this year, along with Tutors and volunteers for working diligently with the community to ensure a sense of caring and inclusion. Thanks to Melanie's leadership, supported by Kate for steering us through a challenging year and sustaining co-operative relationships with both our valued co-tenants, the Highett and Greek Senior Citizens and our event collaborators such as Highett Bendigo Bank, Highett Bowls Club, Moorabbin Primary, St Agnes Primary, Berendale School, Bayside and Kingston councils, and 88.3 Southern FM Radio.

I would like to recognise the last President Marlene Johnson for her great leadership over the many years at both Highett and Hampton. Other Board departures in 2021 included Lan Phung, Dora Denk and Robyn Quilliam-Taylor who made valued contributions during their time on the Board. We warmly welcome the addition of our new Board members Kenzie Miller, Craig Shayer and Rebecca Weavers. We are proud of the diverse range of backgrounds, skills and gender of our board. I'd also like to thank Ruby Tighe-Martin and Helen Martin who have now finished up at the Centres and we thank them for their service.

As 2022 kicks off we are ready to meet any new challenges and look forward to taking our vision forward in our existing and new programs to achieve our Strategic Plan.

# TREASURER'S REPORT HNCH/HCC



In 2021 COVID-19 posed a lot of obstacles to the organisation once again, as both HNCH and HCC were closed for over six months of the year. To keep our community thriving and connected during this unusual period, community development and engagement activities were effectively moved online.

When we were allowed to open at a reduced capacity, our team was making their best endeavours to get our ordinary activities back on track and created a successful nourish program that serviced hundreds of community members over the year.

The audited financial statements reaffirm very healthy financial positions of HNCH and HCC which ensures that our community development activities and events will not be hindered by the lack of financial resources for the foreseeable future.

I am pleased to report our key financial results as follows, on an accrual basis,

HNCH recorded a surplus of \$31,670, the members' equity at 31 Dec 2021 was \$263,907, and the cash and cash-equivalents holding at 31 Dec 2021 was \$376,437.

HCC recorded a surplus of \$11,977, the members' equity at 31 Dec 2021 was \$169,103, and the cash and cash-equivalents holding at 31 Dec 2021 was \$227,087.

We were grateful for the assistance from the government's stimulus support that enabled the continued employment of all staff during difficult times. In the year 2022, although we expect that the uncertainty over the Covid-19 will continue to exist, we are confident that our capable team will cope with the difficulties ahead and our organisation will continue to excel in providing excellent services to our community.

# MANAGER'S REPORT

Welcome back. We are excited (& relieved) to be on site once again and doing what we do best - delivering engaging community activities and events. I won't dwell on the challenges we all faced in various forms in 2021 and instead will toot the horn of our team who continued to deliver innovative and engaging events and activities during the second year of a pandemic.

We hit the ground running in February with the introduction of Nourish. This concept of 'Food Move Connect' came about via our Social Prescription Pilot Project. Feedback from participants was that they wanted community connection via good food, exercise and conversation. Nourish started at Hampton in Feb 2021 with 8 attendees and by July had increased to a solid weekly following of 30 – 40 people. Community members who had never met before were now excited more than ever to come along and chat to others.

I have been working in Community Development for over 20 years and this has been one of the most successful and rewarding grass root programs I have ever been a part of. It has grown organically, through word of mouth, and that is part of the reason behind its success. A huge thank you to our team that make it happen every week, Kate, Bao, Kim, Kerry, Suzy and our team of placement students from Holmesglen and our Monash University Masters of Counselling students. A shout out also to Emelia who has created the colourful Nourish visuals.

We have extended the program to Highett and are also now exploring other Bayside community spaces such as sport pavilions. We are currently undertaking a trial at the AW Oliver Reserve. We are doing this in partnership with Chatty Cafe which has also grown to be across both of our sites. Thank you to Glenys and Helen from Chatty for their support.

This year we had the extra challenge of keeping our community connected during another prolonged lockdown. Our superb admin team, Brodie and Helen, oversaw the delivery of 8 weeks of free daily Zoom classes, with over a thousand community members participating. Unprecedented for us and quite fun to organise. We had such a variety on offer; laughing yoga, drumming, sound healing and on RUOK Day we had a drawing workshop of our beautiful Therapy Dog Chillii.

Thank you to our funders, Bayside Council, Vic Health, Bendigo Bank and Cheltenham Rotary. We have built great relationships with the representatives of these organisations and I'd particularly like to mention Lauren Waycott and Erica Breedon. I'd also like to thank those in our community who have contributed in other ways including Connect Health, Food for Change Barb at Highett Florist, Hodges Sandringham, Hampton Fruit Supply and Hampton Bakery. It is your kindness and donations which allow us to stretch the budget to deliver our programs. Thanks again to Marlene Johnson, our outgoing President and welcome to Marie Louise. We also extend a warm welcome to Kim Hingston as she joins our team.

In 2022 we are committed to providing safe, warm, inviting spaces where our community can come together to connect and create meaningful relationships. We know that these are the bedrock to happy, healthy and inclusive communities and we look forward to welcoming you soon.

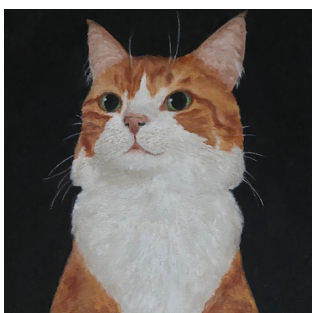
