## SECTION 4: First aid measures

### 4.1. Description of first aid measures

- First-aid measures after inhalation : If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Call a POISON CENTER/doctor/physician if you feel unwell.
- First-aid measures after skin contact : In case of contact, immediately flush skin with plenty of water. Remove contaminated clothing and shoes. Wash clothing before reuse. Call a physician if irritation develops and persists.
- First-aid measures after eye contact : In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. If easy to do, remove contact lenses, if worn. If irritation persists, get medical attention.

### 4.2. Most important symptoms and effects, both acute and delayed

### 5.3. Advice for firefighters

- Firefighting instructions : Cool closed containers exposed to fire with water.
- Protection during firefighting : Keep upwind of fire. Wear full fire fighting turn-out gear (full Bunker gear) and respiratory protection (SCBA). Vapors may be heavier than air and may travel along the ground to a distant ignition source and flash back. Floor will become slippery if material is released.
