CONSIGNMENT IS BY APPOINTMENT ONLY Appointments can be made in person, online, and over the phone. **Consignors may bring a maximum of 25-30 items to an appointment.** There is a one appointment per season limit.

- A staff member will go through your items while you wait.
- Items should be folded neatly and transported in a reusable or recyclable bag. Please, no trash bags!

CONDITION OF CONSIGNMENT All clothing must be in excellent condition, ready to display and wear.

- Clothing should reflect the current and/or upcoming season. Please refer to our website for seasonal guidelines.
- Items must be laundered before being brought in for consignment.
- Items showing signs of damage including but not limited to stains, holes, rips, missing or broken closures, odors, pet hair, and pilling will not be accepted and should not be brought in for consignment.
- Items that are found to be damaged after the consignment appointment will be removed from the racks and donated to charity.
- Raspberry Beret reserves the right to refuse any item no matter the label or condition.

PRICING Items are researched prior to pricing. Prices are determined by Raspberry Beret and are non-negotiable.

- A small buyer's fee will be added to the sales price. The buyer's fee will not affect the consignor's earnings.
- Items are reduced in price after 30 days and are subject to further markdowns (i.e., end of season, holiday, special events) at the discretion of Raspberry Beret.
- Raspberry Beret cannot guarantee the selling price of any given item, nor subsequently a consignor's earnings.

CONSIGNMENT PERIOD The consignment period is 60 days.

- Items not sold during the 60 day consignment period become the property of Raspberry Beret and will be sold as such or donated to charity at our discretion.
- Items priced by Raspberry Beret at \$50 or more are eligible for return after 60 days, by request.
- A minimum of 24 hours notice is required when requesting an item return, and items must be picked up within 7 days of the requested date. Any items not picked up after 7 days will be donated.
- Any item withdrawn by the consignor before the completion of the consignment period will incur a handling fee of two dollars (\$2.00) per item.
- Check the status of your consignment by logging in to our consignor portal!

CONSIGNMENT PAYMENT Consignors receive 40% of each consigned item's sale price. Account balances can be used as store credit during the consignment period and/or be paid out after the consignment period has concluded.

- A discount of 15% will be applied to your purchase when using store credit.
- Payment is available by check, Venmo, and PayPal.
- Payments are issued once monthly for balances of \$20 or more. Balances under \$20 can be used as store credit or rolled into a future check.
- A monthly record is kept for consignor payouts. Contact the store at any time to confirm you are on the list.
- A fee of 50 cents for mailing checks and \$2.00 for digital payouts will be charged to the consignor's account.
- Consignment payment is available by check or digital payout for up to six (6) months after accrual and by store credit for up to eighteen (18) months accrual. Raspberry Beret is not required to pay out account balances exceeding 18 months.
