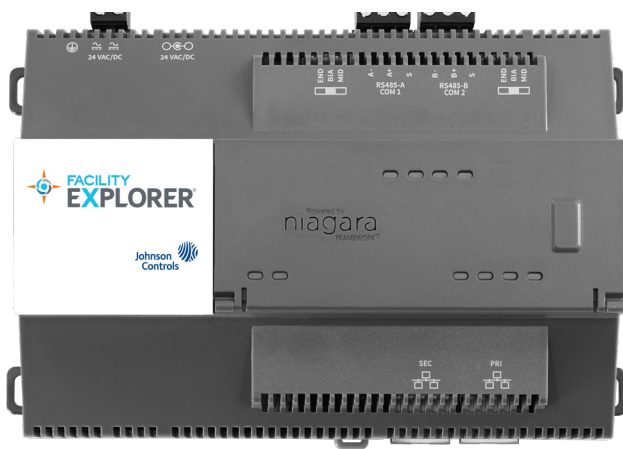

The FX90 provides integrated control supervision and network management services for local networks of equipment controllers. It features scheduling, alarming, historical data collection and management, 3D system graphics, and more. The FX90 Supervisory Controller also supports the exclusive FX Appliance productivity tools to streamline and automate workflows and save time and money from bid to operation.

The new FX90 Supervisory Controller, successor to the FX80, features a modernized hardware platform with advanced features for enhanced performance, further extending supervisory control capability and scalability for current and future needs of building systems.

## Features and benefits

### ■ Faster Processor: Quad core 1.6 GHz iMX8M+CPU (formerly Single core 1 GHz TI AM3522)

Ensures faster boot up and station startup times, making on site commissioning more efficient. The user interface and graphics also provide a more responsive experience.

### ■ Increased memory and storage capacity:

- 2 GB RAM memory (formerly 1 GB)
- 8 GB onboard EMMC storage
- 8 GB uSD (formerly 4 GB uSD)

Increased memory capacity allows for quicker data access and more space for backups and point history. It provides room for future upgrades, reassuring customers of a long operational life once installed.

### ■ Supports the FX Appliance

The FX Appliance offers over 20 distinct productivity features built on top of the Niagara framework. It enables users to quickly build a system configuration database in minutes, with automatic tagging, auto-generated 3D graphics, and more, saving time and money from bid to operation.

## ■ Ability to scale

The FX90 can scale from basic to complex applications with a single hardware platform using orderable device and point licensing. License upgrades can be purchased in the future as needs grow without needing to replace the controller.

## ■ Same footprint, wiring connection locations and orientation as the FX80 and fully compatible with all existing expansion modules

Enables a seamless drop-in replacement or upgrade, saving time and money.

## ■ Stock option

The FX-SC9BASE-0 is purchased separately, stocked, and field-commissioned and field-licensed.

## Stock option

At this release, the FX90 Supervisory Controller is available exclusively as a stock option. The FX90 Supervisory Controller will be commissioned and licensed in the field. This allows you to choose when to commission and start the maintenance period.

**Note:** The FX90 Supervisory Controller requires FX software version 14.13.2 or higher.

A factory commissioned and licensed option will be available for the FX90 Supervisory Controller at a future release. A formal notification will be issued when this option is available.

## FX90 licenses

For every FX90 Supervisory Controller you purchase, you will need a core device license and a software maintenance license. See [Ordering information](#) for the list of available FX90 Core and Maintenance Licenses.

■ A core device license (FX-SC9CL###-0): A core device license is required for each FX90. Core device licenses come in 5, 10, 25, 100, 200, and demo sizes. Only one core license can be applied to each FX90.

■ A software maintenance license (FX-SC9D###M#-0): The software maintenance must match the total number of device licenses (core and additional). Choose from 1, 3, or 5 years.

**Note:** The demo version does not require the software maintenance license. The demo license requires yearly renewal and expires on October 31st.

After the above requirements are met, additional licenses may be added to the FX90:

■ Additional device licenses (FX-SC8DL##-0): These licenses extend the total device license count of an FX80 or FX90. For example, if a total of 50 device licenses are required for an FX90, you would purchase the FX-SC8DL25-0 in addition to the core device license, FX-SC9CL025-0.

**Note:** To order additional device licenses, the same product code FX-SC8DL##-0 applies to the FX80 and FX90 Supervisory Controllers.

## FX80 discontinuation preannouncement

The FX90 Supervisory Controller serves as the successor to the FX80. The FX80 supervisory controller will continue to be available through mid-2025. A formal discontinuation notice with additional details will be issued at a future date.

The FX80 Supervisory Controller extends the base Niagara software, and therefore, the FX supervisory family software is bound by the Niagara maintenance policy. FX 14.15 software, based on Niagara 4.15, will be the last supported long-term release for the FX80. The FX 14.15 long-term release will be available in the future following the availability of the Niagara 4.15 release.
