

OFF-LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Section 40 applies to this licence

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **Old Mate Distillery Limited** (the licensee) is authorised to sell alcohol from the premises situated at **6 Dakota Drive Whitianga** and known as **Old Mate Distillery** to any person for consumption off the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold from the premises at any time on any day and delivered somewhere else for consumption off the premises.
2. No alcohol is to be delivered from the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
3. No alcohol is to be delivered to the buyer (or to any other person on the buyer's behalf) at any time between 11:00pm and 6:00am the following day, on any day of the week.
4. The licensee must follow the procedures set out in Regulations 14 & 15 of the Sale and Supply of Alcohol Regulations 2013 to ensure that neither the purchaser nor the person to whom alcohol is delivered is a minor.
5. There must be a certificated manager properly appointed to the business by the licensee.
6. The Licensee must state the licensee's name, licence number and the date the licence expires:
 - a. On every receipt issued for alcohol sold remotely;
 - b. In every catalogue, if alcohol is sold by remote sale using catalogues;
 - c. On the internet site, if alcohol is sold by remote sale using an internet site;
 - d. If alcohol is sold by remote sale using an internet site, the site must also display either a legible image of the licence, or a clearly identified link to such an image.
7. The outside of the delivery packages must contain the following words –

COURIER WARNING – CONTAINS ALCOHOL

Do not leave at destination without proof of delivery;

Do not leave with persons under 18 years of age. If the receiver appears to be under the age of 25 years check valid identification such as a current passport, NZ driver's licence of Hospitality NZ 18+ Card/Kiwi Access card, to ensure the receiver is 18 years of age or over;

Do not leave with intoxicated persons;

Endorsed – "Contains alcoholic product".

THE LICENSED PREMISES

The sale or delivery of alcohol is authorised in or from the premises generally. The premises, situated at **6 Dakota Drive Whitianga**, is more precisely identified as outlined in a plan date stamped as received by the Thames-Coromandel District Licensing Committee on the **14-March-2022**

Duration:

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

(a) either-

(i) until the close of the period for which it was last renewed; or

(ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued
