

# **KEY OBJECTIVES, VISION, PURPOSE AND CORE VALUES:**



3. The objects of the Federation are:

a) Cycling: To encourage, promote, organize, develop and control the art and pastime of cycling in Singapore.

(b) Cyclists: To support and protect the interest of cyclists in Singapore.

(c) Bicycle Racing: To control bicycle racing and arrange bicycle race meetings in Singapore, and to give technical advice or other instructions thereon.

(d) Representatives: To select competitors to represent Singapore or the Federation.

(e) Prizes etc.: To give prizes, medals and other awards, and to obtain, collect, receive and hold funds and property by subscription, voluntary contributions, gifts or legacies or otherwise, for the objects of the Federation.

(f) Disputes :. Any dispute arising amongst Members or between any Member and the Federation shall be resolved in accordance with the Framework for Alternative Dispute Resolution for Sports (ADR Sports) or other dispute resolution framework jointly administered for the time being by Sports Singapore, the Singapore Mediation Centre and the Singapore Institute of Arbitrators.

(g) Promotion and Funding: To promote and safeguard the interests of the sport, and employ, when necessary, the funds of the Federation for the purpose. To also increase participation and promote community engagement and bonding through the sport of Cycling, in order to promote health and wellness, inclusiveness and integration, and inspire the Singapore Spirit.

(h) Affiliations: To affiliate with the Singapore Sports Council ("SSC"), Singapore National Olympic Council ("SNOC"), the International Cycling Union (Union Cycliste Internationale or "UCI"), BikeTrial International Union ("BIU"), the Asean Cycling Association (ACA), the Asian Cycling Confederation (ACC) or other international body or bodies whose objects are the same as or similar to those of the Federation.

(i) Competitions: To sponsor, support and/or participate in any national or international cycling races or competitions.

(j) Cycle Titles: To decide on the official recognition of cycling titles established in Singapore.

(k) Anti-Doping: The Federation shall recognise the right of all its athletes to participate in clean sport and is committed to ensuring the sport is doping-free. All affiliates, members, athletes, participants, staff and other individuals, who are subject to the jurisdiction of the Federation are bound by and agree to abide by all World Anti-Doping Code-compliant anti-doping rules applicable to the sport. (I) Misc: Generally to do all such other acts or things as may be incidental to or connected with or conducive to the attainment of any of the above-mentioned objects.

The Management Committee shall determine the Mission, programmes and activities of the Federation for the period prescribed by SSC, and shall ensure that they are consistent with the abovementioned objects of the Federation.

#### Selection and Recruitment of Management Committee (MC) Members

- 4. In accordance to the SCF Constitution, an individual member is eligible to stand for office on condition that the individual fulfils the following:
  - a. is 21 years and above as at the date of the relevant meeting;
  - b. is of good standing in the cycling fraternity in Singapore; and
  - c. does not and shall not hold any salaried positions within the Federation nor receive any compensation for his / her role as an office holder.
- 5. Notwithstanding the above, the Management Committee encourages anyone who has the passion to grow and develop the sport of cycling as well as the necessary skill sets and experience (as listed below) to come forward to volunteer.
- 6. Relevant skill sets or work experience include (non-exhaustive):
  - a. Sports Management, Business Management
  - b. Coaching, Sports Science
  - c. Understand the technicalities of the sport of cycling
  - d. Public relations and Integrated Communications
  - e. Social media management
  - f. Marketing (and digital marketing)
  - g. Sponsorship and asset/rights management
  - h. Finance, accounting, auditing
  - i. Human Resource Management
  - j. Information Technology
  - k. Legal
  - I. Project and Event Management
  - m. Managing a Charitable Organisation or an Institution of Public Character
- 7. For an individual who is keen to assume the post of an incumbent office holder, by the time of the next AGM (Annual General Meeting), he/she would be encouraged to commit to volunteer his/her services for minimally one year or the full term of two years in office as an Associate Member and to understudy the incumbent office holder.



# **Staffing and Organisational Structure**

- 16. The Secretariat of the Singapore Cycling Federation (SCF) is headed by Mahipal Singh s/o K. Ishar Singh, the General Manager, who was appointed on 1 Apr 2014.
- 17. Prior to joining the SCF, Mahipal spent 21.5 years (between Feb 1991 and Jun 2012) in the Singapore Sports Council, SSC (Sport Singapore), where he was responsible for the overseeing the day to day operations of National Sports Associations (NSAs) high performance planning and implementation, coach education and development and also held leadership responsibilities during the 1993 SEA Games (Singapore), Asian Youth Games in 2009 (Singapore), the Youth Olympic Games in 2010 (Singapore) and at other major international multi-sports events including the Commonwealth Games, Asian Games, Asian Indoor Games and the South East Asian Games. His last held position in the SSC was that of a Deputy Director, Coaching Services, Singapore Sports Institute
- 18. As at 31 March 2021, there were 12 full time and 1 contract staff.

- 20. None of the three (3) highest paid staff also served as a Management Committee member of the SCF. In addition, there is no paid staff being a close member of the family belonging to the General Manager or a Management Committee member of the SCF who has received remuneration in excess of \$50,000 during the financial year.
- 21. On matters of salary increments, salary adjustments and promotions as well as staff performance review, the SCF's Human Resource (HR) Committee would make reference to its in-house developed Salary Guide.
- 22. The SCF's HR Committee comprises the President, Secretary-General, Hon Treasurer and VP (Media and Publicity). The composition of the Committee is on two-year term from Sep 2019 to Sep 2021.

Remuneration for key staff (as adapted from the SCF Constitution)

- 23. The Management Committee may by way of a unanimous vote of the Management Committee members recruit any person to be its Chief Executive Officer, General Manager, Technical Director, or such other key or other staff on a full time or on a part time basis, or any entity with the relevant qualification and ability, to manage the operations of the Federation. The Management Committee will make such recommendations to Sport Singapore as part of its annual funding/budgetary requirements prior to recruiting such persons or entity(ies).
- 24. For key executives eg. the Chief Executive Officer, the Federation and SSC shall jointly recruit such key staff through joint interviews and evaluation, and the appointment of such key staff will be subject to Sport Singapore's approval, which will not be unreasonably withheld.
- 25. The appointment, remuneration, key performance indicators and terms of employment of such staff shall be determined by the Management Committee and approved by Sport Singapore.
- 26. The Management Committee shall formulate policies and procedures to help assess, screen, supervise and train volunteer appointees including procuring appropriate HR provisions for its staff, officials and volunteers, e.g. insurance coverage. Such decisions will be documented in the meeting minutes of the Management Committee.

# Conflict of Interest Declaration

27. On an annual basis, all MC members and staff would be required to make a conflict of interest declaration. A staff or MC member who declares that he/she has existing/potential conflict of interest is required to state the conflict of interest (including persons, companies with whom/which he/she has official dealings and/or private interest) and for this to be escalated to the President,

SCF. He/She will then be required to recuse himself/herself from all transactions, recommendations or decision making on matters pertaining to the subject matter in which he/she is in a conflicted position.

# **National Championships**

- 29. The SCF entered into a sponsorship agreement with OCBC Bank, valued at \$90,000.00 for one year (Jan to Dec 2020). The sponsorship monies was to be used solely for the purpose of organising local competitions under a title sponsorship arrangement viz. "OCBC Cycle."
- 30. The annual series of National Championship events were cancelled in 2020 due to the Covid-19 outbreak. This resulted in the suspension of the OCBC Cycle National Ranking System for 2020. As for the sponsorship from OCBC Bank, this would be carried forward and utilised in 2021.

#### **Community Outreach and Regional, International Competitions**

The global outbreak of Covid-19 had a major impact on many local events, regional and international competitions as well as courses and programmes which the SCF had planned to organised – most were cancelled but following the easing of restrictions on events and

activities involving a sizeable number of participants, the SCF managed to organise, support the following:

# SCF National Day 2020 Indoor Cycling Challenge

- 31. The inaugural SCF National Day 2020 Indoor Cycling Challenge was organised in conjunction with the Get Active Singapore! Active Enabler Programme (AEP). The event is in line with the call for the organisation of home-based activities for Singaporeans to remain active and united as part of the annual GetActive Singapore campaign.
- 32. The event comprised both Community and Competitive events. The Community event featured three separate activities as follows:

33. The Competitive Event comprised a Road Race Challenge on 8 August and an Individual Time Trial (ITT) on 9 August. There were five race categories and a total of 20 races were organised for men's and ladies. Mr Lim Teck Yin, CEO of Sport Singapore, was the Guest of Honour for the Road Race Challenge on 8 August 2020.

**ProCyclingSG** 

34. A series of ProCyclingSG educational workshops were also streamed "live" on Youtube and Facebook on 27 June 2020, 1 August 2020, 5 September 2020, 10 October 2020, 5 December 2020 and 5 March 2021. The first workshop featured Adrian Ng, GM of ProCyclingSG as well as Andrew Smith of GreenEdge Cycling and moderated by Lim Jia Yean of Deloitte. The workshops featured topics on: Ep1: Riding into Phase 2 Ep2: Progressive Training Ep3: Structured Training Ep4: Recovery Ep5: Specialisation Ep6: Easy Gains

35. In celebration of the nation's 55<sup>th</sup> year of independence, Togoparts organised the #TOGOSG55 Challenge between 1 and 16 August 2020. This event was supported by SCF with the participation of national athletes.

- 36. A squad of nine riders between the age of 13 and 18 years commenced training on 1 June 2019. These young riders will continue to train together, adhering to a structured training programme and the intent would be to expose them to training stints and state-level competitions in Malaysia.
- 37. SCF Academy MTB The squad comprises 65 riders between the ages of 4 and 16 years of age. The squad was managed by Academy Director Hairul Nazwa as well as Junaidi Hashim.

- 42. The Singapore Sports Awards was held at the Singapore Sports Hub on 28 Oct 2020. Luo Yi Wei (Road) and Riyadh Hakim (MTB), were duly recognised and they were awarded the SNOC Meritorious Award.
- 43. Goh Choon Huat, Donaben, became SCF's fourth spexScholar when he was offered this prestigious award in March 2021.

#### **REVIEW OF FINANCIAL STATE AND EXPLANATION OF MAJOR FINANCIAL TRANSACTIONS**

- 44. Sport Singapore approved a total of \$1,187,523.22 for FY 20 (including \$16,700 in the form of a matching grant) and, a further \$90,874.89 (20,176.75 + \$70,698.14) in the form of direct athlete funds and a spexScholarship grant.
- 45. The Secretariat ensured that funds were utilised for its intended purposes and provided half-yearly reports to Sport Singapore on this.
- 46. S B Tan Audit PAC was responsible for auditing SCF's accounts for FY20. As at 31 March 2021, the SCF's was in a favourable position with accumulated funds totalling \$561,985.49. Apart from funding received from Sport Singapore, the SCF managed to generate additional income from events organised, through the Cycle Safe Accredited training partner arrangement and licences/membership fees. Where such conflicts exist, the MC will evaluate whether any potential conflicts of interest will affect the continuing independence of MC members and whether it is appropriate for the MC member to continue to remain on the MC.

- 50. On a quarterly basis (i.e. Management Committee meetings), the SCF MC reviews the amount of reserves that are required to ensure that they are adequate to fulfil our continuing obligations, provide financial stability and the means for the development of our principal activity. In FY 20, the SCF had set aside \$139, 815 as restricted funds. This amount was obtained through a Sport Singapore matching grant scheme "One Team Singapore Fund." The amount was set aside primarily to defray costs (high performance specific programmes and initiatives) to be incurred on the Road, Track, BMX and MTB National Training Squads in preparation for and participation in regional and international competitions and equipment/apparel purchases.
- 51. In order to also ensure that our reserves are adequate to fulfil our continuing obligations, the SCF will set aside at least six months of reserves for expenditure on rental, office operations and staff salaries.

# **FUTURE PLANS**

# Strategic Plans

52. The SCF will initiate a tie-up with the NUS Business School to (a) conduct a review of its plans for the period between 2015 and 2020 and (b) develop plans for the next five years from 2021. It is anticipated that this project will be completed by end Apr 2021.

# Local events

- 53. From 2021, the SCF will be organising all National Championship and other secondary events utilising in-house capabilities and expertise.
- 54. The SCF will be sanctioning one event in 2021 viz.
  - a. OCBC Cycle Speedway (Club) Championship to be held on 29 May 2021

# Asian Cycling Confederation (ACC)

55. The ACC held its Annual General Meeting (AGM) on Monday, 22 March 2021 via an on-line meeting platform. This was an election year and incumbent President, Mr Osama Al-Shafaar (UAE) managed to retain his seat for another four-year term until 2025. Singapore Cycling Federation, represented by Dr Hing Siong

Strategically these appointments are of significance as we look to make our presence felt in Asia as well as the UCI. The appointments would be for a four-year term.

- 56. SCF's other primary focus for 2021 would include:
  - a. Resumption of activities, in consultation with Sport Singapore.
  - b. High Performance programmes and initiatives, including preparation for the SEA Games in Nov 2021 and the Asian Games in 2022 as well as activities involving the ProCyclingSG Squad.
  - c. Leadership renewal.
  - d. Safe cycling activities including partnerships with key stakeholders.
  - e. Establish links with local cycling clubs both competitive and social/leisure cycling clubs/interest groups.
