In addition, HP will work closely with partners in select countries on the initial roll out of two distinct tracks:

- **Catalyst:** Catalyst members will take the HP Amplify Impact Pledge, participate in a sustainability assessment, and report sales opportunities. Initial roll out includes 19 countries: United States, Colombia, Brazil, Mexico, Turkey, UAE, Singapore, Philippines, India, Germany, UK, Sweden, Denmark, France, Italy, Spain, Canada, South Africa and Australia.
- **Changemaker:** The Changemaker track is optimized to assist partners that do not yet have a sustainability plan in place and commit to investing in the sustainability journey. HP will closely collaborate with and support Changemaker members in the development of a long-term sustainability plan which will put them on a path to be recognized as a business that is focused on creating meaningful change. Initial roll out includes 7 countries: France, Italy, Spain, Canada, South Africa, Australia and select partners in the United States.
