# SMART-STAT REMOTE CONTROL KIT

#### INTRODUCTION

The SMART-STAT Remote Control has been approved for use with decorative gas fireplaces and wall heaters which are certified and listed by UL, A.G.A., CGA, and Warnock Hersey. Refer to the gas appliance instruction manual.

The SMART-STAT is a hand held transmitter that can be used as a remote on/off or as a thermostat. The display of the SMART-STAT shows the current room temperature, target temperature, timer setting, on/off status and low battery indicator. Electrical ratings for the SMART-STAT receiver are: 110 VAC, 60 Hz, 2.2 W.

# CHECK CONTENTS OF SHIPPING CARTON

Compare contents of carton in Figure 1 with the actual parts received. If any parts are missing or damaged, contact your dealer before starting installation. DO NOT install a damaged remote control kit.

## INSTALLATION PRECAUTIONS

The SMART-STAT Remote Control Kit is tested and safe when installed in accordance with this installation manual. It is your responsibility to read all instructions before starting installation and to follow these instructions carefully during installation.

Installation of this kit MUST be done by a qualified service technician.

NOTE: The factory installed junction box in the gas fireplace must be wired with 110 VAC before installing this kit. See Section 1.1.

The SMART-STAT is carefully engineered and must be installed only as specified. If you modify it or any of its components, you will void the warranty and you may possibly cause a fire hazard.

**CAUTION**: All wiring should be done by a qualified electrician and shall be in compliance with local codes and with the National Electric Code ANSI/NFPA No. 70-current (in the United States), or with the current CSA C22.1 Canadian Electric Code (in Canada).

WARNING: DO NOT CONNECT 110-120 VAC WIRING TO THE GAS CONTROL VALVE OF THIS APPLIANCE.



#### **FCC REQUIREMENTS**


#### 1.0 INSTALLATION INSTRUCTIONS

# 1.1 INSTALLING ELECTRICAL SERVICE TO THE JUNCTION BOX

# WARNING: TURN ELECTRICAL POWER OFF AT THE CIRCUIT BREAKER BEFORE BEGINNING THIS INSTALLATION.

- Remove the electrical cover plate from the lower side of the fireplace. Remove the knock-out from the plate and attach the romex clamp (screws to the outside). See Figure 2.
- 2. Feed the electrical service wires through the romex clamp and secure the wires to the clamp.
- 3. Using the wire nuts provided, connect the service wires to the junction box. The black wires to the black service wire, the white wires to the white service wire, and the service ground wire to the ground stud of the junction box.
- Re-attach the cover plate to the outside of the fireplace.

WARNING: LEAVE ELECTRICAL POWER OFF AT THIS TIME. DO NOT RESTORE POWER UNTIL THE SMART-STAT SYSTEM IS COMPLETELY INSTALLED. (SEE 2.0).




# 1.2 INSTALLING THE SMART-STAT REMOTE RECEIVER

Place the receiver into the base pan of the fireplace.
The receiver MUST be on the right front side, directly behind the bottom louvers. See Figure 3.

# CAUTION: LAY THE RECEIVER AND WIRES FLAT ON THE BASE PAN TO AVOID POTENTIAL OVER-HEATING PROBLEMS.

 Find the red and brown pigtail wires (labeled "FOR USE WITH REMOTE OR WALL SWITCH ONLY") which are attached to the fireplace ON/OFF rocker switch. Connect these pigtail wires to the red low voltage wires that are attached to the remote receiver by plugging in the male to female connectors.

- Turn the ON/OFF rocker switch of the fireplace to the "OFF" position.
- 4. Place heat shield over the receiver. Be sure the heat shield does not rest on any wires. See Figure 3. NOTE: Heat shield will not work in insert units because of space limitations.
- 5. Turn the electrical power "ON" at the circuit breaker. The SMART-STAT is now ready to operate the fire-place.



# 2.0 INSTALLATION INSTRUCTIONS FOR MODEL AT-ZC FIREPLACE INSERTS

WARNING: DO NOT INSTALL A REMOTE RE-CEIVER INSIDE THE BASE PAN OF MODEL AT-ZC FIREPLACE INSERT.

WARNING: TURN ELECTRICAL POWER OFF AT THE CIRCUIT BREAKER BEFORE BEGINNING THIS INSTALLATION.

#### 2.1 INSTALLING THE REMOTE CONTROL

- Plug the remote receiver directly into a 110VAC wall outlet and run the low voltage wires attached to the receiver through a pre-punched hole in the side of the appliance.
- 2. Find the red and brown pigtail wires (labeled "FOR USE WITH REMOTE OR WALL SWITCH ONLY") which are attached to the appliance ON/OFF rocker switch or gas control valve (fireplace insert models). Connect these pigtail wires to the low voltage wires attached to the remote receiver by plugging in the male to female connectors.
- Turn the ON/OFF rocker switch of the insert to the "OFF" position.

## 3.0 OPERATING INSTRUCTIONS

CAUTION: This remote will automatically turn the fireplace off after 6 hours of continuous operation.

#### 3.1 CHILD PROOF FEATURE

- Slide open the battery door to expose the child-proof switch.
- 2. Slide the child-proof switch to CP position to enter Child Proof Mode. Child Proof will appear on the LCD.
- 3. In child-proof mode the buttons will be inoperable.
- 4. Pressing the On/Off button in the following sequence (LONG - SHORT - SHORT - LONG - SHORT) will temporarily enable the buttons. Long is pressing the button for longer than 0.5 seconds and short is pressing the button for less than 0.5 seconds. Child Proof will disappear from the LCD.
- After 2 minutes the transmitter will automatically go back to Child Proof Mode.
- **6.** Slide the child-proof switch back to the other position to turn off the Child Proof Mode.

#### 1. STANDING PILOT APPLIANCES:

FOLLOW SAFETY AND LIGHTING INSTRUCTIONS TO LIGHT THE PILOT AND SET THE CONTROL VALVE KNOB TO "ON". THEN FOLLOW THE SMART-STAT OPERATING PROCEDURES.

#### 2. DSI APPLIANCES:

ONCE ELECTRICAL POWER IS RESTORED TO THE JUNCTION BOX, SIMPLY FOLLOW THE SMART-STAT OPERATING PROCEDURES.

#### **OPERATING MODES**

The SMART-STAT Remote has three operating modes - Manual, Thermostat, and Timer.

- You must ALWAYS adjust the target temperature setting on the transmitter to a point GREATER than room temperature to enable the device to work in the Manual or Timer modes. If the Target Temperature setting is LESS than room temperature the Thermostat mode will override and operate the fireplace.
- 2. You must also ALWAYS push the ON/OFF button to "ON" for ALL three operating modes.

#### TRANSMITTER ACCESS DOOR

The access door on the front of the transmitter must be opened to operate the "TIME CANCEL" and "TIME SET" buttons. Lift up on the tab on the right side of the transmitter to open access door. See Figure 4.



#### SETTING THE ON/OFF BUTTON

Push the ON/OFF button once to turn the remote control "ON". The "ON" indicator on the LCD will be displayed.

#### **SETTING TIME**

- 1. Press and hold the "Time Set" button for approximately 2 seconds. The hour display will flash. Use the "UP ARROW" and "DOWN ARROW" buttons to set the hour.
- 2. Press and hold the "Time Set" button again and the minute display will flash. Use the "UP ARROW" and "DOWN ARROW" buttons to set the minutes.
- 3. Press the "Time Set" button again to exit setting.

#### SETTING TEMPERATURE

Adjust the target temperature between 45 degrees F and 90 degrees F, with increments of 1 degree F. Push the "UP ARROW" button to increase the temperature setting and the "DOWN ARROW" button to decrease the temperature setting.

WARNING: The gas appliance will not shut off if the transmitter battery goes dead. This may create a potential hazard. Manually turn the appliance off until a charged battery is restored.

#### 3.2 OPERATING MODES

## A. MANUAL OPERATION

- 1. Set the target temperature to 90°.
- 2. Press the ON/OFF button once to light the fireplace. Push the button again to turn it off.

NOTE: If the room temperature exceeds the target temperature the thermostat will automatically turn the fireplace ON/OFF.

#### **B. TIMER OPERATION**

- 1. Set the timer to the length of time you want the fireplace to operate (1 to 120 minutes).
  - Press the "TIME SET" key once, the time set display "---" will blink.
  - Press the "UP ARROW" and "DOWN ARROW" keys to select the time setting. The LCD will display the time chosen.
  - After the chosen time has expired, the LCD will display "---" and "OFF".
  - The timer setting can be cancelled at any time by pressing the "TIME CANCEL" button.
- 2. Press the ON/OFF button to "ON".
- 3. Set the desired target temperature ABOVE room temperature. NOTE: If the room temperature becomes greater than the target temperature - the thermostat will override the timer and turn off the fireplace. The fireplace may re-light with time remaining on the timer once the room temperature drops below the target temperature setting.
- 4. The fireplace will turn "OFF" at the end of the time setting OR when the room temperature becomes greater than the target temperature.

# C. THERMOSTAT OPERATION

- 1. Press the ON/OFF button to "ON".
- Set the target temperature to the desired temperature for the room.

The thermostat will automatically turn the fireplace on as long as the target temperature is greater than the actual room temperature. When the room temperature is greater than the target temperature, the fireplace will turn off.


# 3.3 SMART-STAT BATTERIES

The transmitter uses 3 AAA-size batteries. Replace these batteries as required.

WARNING: DISCONNECT REMOTE CONTROLS IF YOU ARE ABSENT FOR EXTENDED TIME PERIODS. THIS WILL PREVENT ACCIDENTAL FIRE-PLACE OPERATION.

# 4.0 IMPORTANT SAFETY FEATURE

You can set a private code into your SMART-STAT system to prevent accidental operation by other transmitters near by. See Figure 5.



# 4.1 CODING INSTRUCTIONS

Remove the cover on the back of the transmitter, by sliding it off where indicated, to expose the code switches. Slide the code switches to your choice of ON or OFF positions. FACTORY SETTING IS ALL "OFF". Next, remove the cover on the back of the receiver, by sliding it off where indicated. Slide the code switches to exactly match the settings on the transmitter. Replace the respective covers. The system is now ready to operate.
