### **PORTABLE AUDIENCE SEATING: INDIVIDUAL CHAIR PROTECTION SYSTEM**

#### **PART 1 GENERAL**

##### **1.1 WORK INCLUDED**

- A.** Provide all equipment and materials, and do all work necessary to furnish and install the individual chair protection system, as indicated on the drawings, and as specified herein.

- A.** Examine contract documents for requirements that affect work of this section. Other specification divisions and sections that directly relate to the work of this section include, but are not limited to:

##### **1.3 REFERENCES**

- A.** Comply with applicable requirements of the following standards. Where these standards conflict with other specified requirements, the most restrictive requirements shall govern.

1. Manufacturers Data and Recommended Installation Requirements.
2. Synthetic Turf Recommend Loading and Installation Requirements.

##### **1.4 SUBMITTALS**

- A.** Manufacturers Product Data

1. Provide manufacturers product data for Architects or Owners representative review.

##### **1.5 PRODUCT DELIVERY AND STORAGE**

- A.** Upon arrival at the site, it is essential to inspect the materials for any signs of damage or shipping defects. In the event of any defects, it is imperative to make a note of them and inform the representative of the Owners. If replacements are deemed necessary, they should be promptly reordered to avoid any disruptions to the construction schedule. It is

vital to store all sound materials above ground with adequate protective cover or indoors to ensure their proper safeguarding.
