**ANNEX 1**

Below is an extract of information provided by IFRA in relation to types of application present in each IFRA Category. Additional information about IFRA Categories can be found in the Guidance to IFRA Standards, issued by IFRA.

IFRA Category 1	Products applied to the lips: Lip products e.g. lipstick, lip balm; Childrens toys
IFRA Category 2	Products applied to the axillae: Deodorant and antiperspirant products of all types; Body sprays/mists
