

DONNING THE CLOTHING

Clothing should be a good fit. Ill-fitting clothing could present a hazard and should not be worn. Ensure the methods of fastening the garments where provided are used while wearing. When you need to take your protective clothing off, the clothing should be visually inspected for signs of wear and damage which may impair the performance of the garment. Damaged clothing will not provide the protection stated in the user information sheet and should be replaced. Dirty clothing may lead to a reduction in protection. Strong cleaning agents e.g. bleach should not be used. After rinsing in clean water, they can be hung up to dry in a current of air but away from a direct heat source or sunlight. Do not dry on a hot surface.


Garments should not be repaired by the user. If required, garments may be returned to Bennett Safetywear Ltd for evaluation to see if the garment can be repaired and once repaired may not perform in the same manner as a new items.

DISPOSAL OF CLOTHING

Clothing is currently not recycleable and should be disposed responsibly and in a environmentally friendly manner.

Packaging / Storage: The garments shall be packed individually in polymeric bags and will be labelled with the appropriate marking with regards to amount, type, size, manufacturer, performance level and CE mark and shall contain the user instructions for the minimum resale quantify. These are then placed in cardboard cartons. Store in original packaging. Store away from direct sunlight to maintain the optimum properties. This is suitable for transportation and storage. Ideally stored between 5 and 25°C in a dry well ventilated area in original packaging.

Care instructions: In the event of mild contamination garments may be rinsed in water and allowed to drip dry in ambient temperatures.



OBSOLESCENCE

Stored correctly, the clothing's physical properties will not change for up to five years. Each garment will contain labels containing similar details.

This series satisfies the basic requirements of the PPE regulations, being innocuous / free from nuisance factors, ergonomic, and breathable. Conditions of use are not simulated by the test results and as such service life cannot be specified. Results should be used for quidance in initial selection.
