We collect Device Information using the following technologies:

- "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.
- "Web beacons", "tags", and "pixels" are electronic files used to record information about how you browse the Site.

When we talk about "Personal Information" in this Privacy Policy, we are talking both about Client Information and Device Information.

How do we use your personal information?

We use the Client Information that we collect generally to fulfil requests placed through the Site (including providing you with quotations and advise). Additionally, we use this client Information to:

- Communicate with you;
- Screen service requests for potential risk or fraud; and
- When in line with the preferences you have shared with us, provide you with information or advertising and marketing relating to our services.

We use the Device Information that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site, and to assess the success of our marketing campaigns).

Sharing your personal Information

We share your Personal Information with third parties to help us use your Personal Information, as described above.
