- 2. Shareholders who wish to attend The Lakes Court Meeting in person will be able to do so. The Company strongly encourages all shareholders to vote in advance by submitting this form of proxy in accordance with the instructions set out in this form of proxy (or as provided for in the Scheme Document) as soon as possible. - 3. The Court has appointed Paul Neep, or failing him James Pennefather, or failing him David Robinson, or failing him any other director of the Company, each being directors of the Company to act as Chairman of The Lakes Court Meeting and has directed the Chairman to report the result thereof to the Court.
