## SECTION 4 – FIRST AID MEASURES

<b>Inhalation</b>	Remove victim to fresh air away from exposure. Obtain medical attention if symptoms occur.
<b>Skin contact</b>	Immediately wash contaminated skin with plenty of soap and water. Remove contaminated clothing and wash before re-use. Seek medical advice (e.g. doctor) if irritation, burning or redness persists.
<b>Eye contact</b>	If in eyes, hold eyelids apart and flush the eyes continuously with running water. Remove contact lenses. Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes. Immediately call a POISON CENTER or doctor/physician.

## SECTION 5 – FIRE FIGHTING MEASURES

## SECTION 6 – ACCIDENTAL RELEASE MEASURES

<b>Emergency Procedures</b>	Minor spills do not normally need any special clean-up measures – rinse with water. In the event of a major spill, prevent spillage from entering drains or water courses. Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. As a water based product, if spilt on electrical equipment the product will cause short-circuits. If possible contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Neutralise any residues with SODIUM CARBONATE or SODIUM BICARBONATE. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

## SECTION 7 – HANDLING AND STORAGE

<b>Handling</b>	Avoid skin or eye contact with concentrate. Wear protective clothing when risk of exposure occurs. Avoid contact with incompatible materials. When handling, DO NOT eat, drink or smoke. Keep containers closed at all times. Avoid physical damage to containers. Always wash hands with soap and water after handling. Work clothes should be laundered. Launder contaminated clothing before re-use.

<b>Body Protection</b>	Suitable protective workwear, e.g. rubber or plastic apron, sleeves, boots and cotton overalls



buttoned at neck and wrist are recommended. Chemical resistant apron is recommended where large quantities are handled.

**Respirator**

Generally not required for typical applications with diluted solutions as per label directions. Not required for normal cleaning operations with adequate ventilation.
