These terms and conditions govern the sale of Woolpets® brand products to authorized Woolpets® retailers. woolpets, llc d/b/a Woolpets® provides these terms, conditions and policies in an effort to service the retailer in a manner consistent with our reputation as a supplier of high quality craft kits and supplies. Woolpets® is allowing you (Authorized Retailer) to purchase our products at wholesale prices as long as you abide by our terms, conditions and policies regarding the promotion and sale of our products.

MINIMUM ADVERTISED PRICE (MAP) POLICY.

We have implemented a minimum advertised pricing policy ("MAP" policy) to protect the Woolpets[®] brand name and to support the products on a consistent basis. We will not support or sell to Authorized Resellers that advertise our products at less than "MAP" prices. Our "MAP" policy applies to advertised prices, which means print, direct mail, broadcast, catalog and electronic media including Internet e-commerce sites. Violation of this "MAP" policy will result in immediate termination of your account in addition to the penalties set forth in this policy. Should this occur all unpaid invoices will become immediately due and payable. All current and future Woolpets[®] items shall be covered by this "MAP" policy unless otherwise indicated in writing by woolpets, ilc, and woolpets, ilc reserves the right to change this policy at anytime.

ORDER REQUIREMENTS.

- Minimum opening order of \$200.00.
- Reorders below \$150.00 are subject to a \$10.00 handling fee.
- Prices and product availability are subject to change without prior notice. Manufacturer reserves the right at any time to change, discontinue or modify the design and construction of any of its products.

BACKORDERS.

- ❖ Backorders under \$50.00 dollars will be canceled unless otherwise noted on the order.
- ❖ Backorders that initially qualified for FFA are shipped FFA.

RETURN POLICY.

- All sales are final. Returns are only permitted with authorization from an authorized employee of Woolpets.
- Returned and refused shipments are subject to a 25% restocking fee. All return freight is to be paid by the customer
- Claims for merchandise shortage or damaged goods must be made within 10 days of receipt of shipment.
- In the event that an Authorized Reseller intends to go out of business, the Authorized Reseller shall immediately contact Woolpets, LLC and request a return goods authorization for credit provided that the merchandise is resalable. Liquidation of Woolpets® brand products is strictly prohibited.

PAYMENTS.

- Payments must be made via credit card (Visa, Mastercard, Discover, and American Express) or PayPal until an open account can be established. To establish an open account you must provide us with at least three (3) credit references. We have complete discretion regarding whether to establish an open account with you.
- Past due accounts are subject to a late payment fee equal to two percent (2%) per month of the outstanding balance. We will charge a late payment fee for each month that your past-due account remains unpaid.
- ❖ We charge a \$50.00 dollar fee for each returned check.
- All merchandise remains the property of Woolpets[®] until invoice is paid in full.

SHIPPING/FREIGHT.

- All products are shipped FOB Kent, Washington via UPS Ground unless otherwise specified and agreed to by woolpets, Ilc.
- We make every effort to ship promptly but you should allow one (1) to two (2) weeks from the date of acceptance of your order before shipment. We cannot guarantee that the product you order is in stock, when your order will ship, or when you will receive your order.
- Delivery means delivered to the address listed on the purchase order and signed for at that address. We are not responsible for unauthorized signers, loss, or damage after the shipment has been excepted.
- Manufacturer will not be liable for any delay in the performance of its obligations under the Order, or for any damages suffered due to such delay, including but not limited whether or not the delay is, directly or indirectly, caused by a fire, flood, accident, civil unrest, act of God, war, governmental interference or embargo, labor strike, shortage of materials, or any other cause beyond our control.
