SECTION 4 – FIRST AID MEASURES

4.1 DESCRIPTION OF NECESSARY FIRST AID MEASURES:

INGESTION:

Rinse mouth out with water. Due to the blend of ingredients present, the manufacturer recommends that if swallowed, do NOT induce vomiting. ACUTE:

CONTAINMENT:

Contain the spill and absorb with a proprietary absorbent material, sand or earth. For large spills prepare a bund/barrier/dyke ahead of the spill to confine the spill and allow later recovery. If there is the possibility of spills to enter drains, surface water, sewers or watercourses ensure bunding, or that drains are covered, to minimise the potential for this to occur.

CLEANING PROCEDURES:

Small spills can be cleaned up by hand using a cleaning cloth. Having contained the spill, as mentioned above, collect all material quickly and place used absorbent in suitable containers.
