

DISPOSAL OF LIQUID AND SOLID WASTE FROM THE PROFESSIONAL HAIRSTYLING ACTIVITY







As per Law Decree dated 18 September, 2000, no. 218, on water protection, professional hairstyling activities are considered civil establishments, from which waste waters may be discharged into the sewage system as such, provided the regulations of the local authorities (Municipal authorities, Consortia) managing the public sewage system are complied with.

Used empty bottles or containers shall be considered, for disposal purposes, special waste equivalent to urban waste, as per the "Criteria of Equivalence of Special Waste with Urban Waste" established by the provisions of the Italian interdepartmental committee with resolution dated 27 July, 1984 (Supp. to the Official Gazette no.253 dated 13/09/ 84) and therefore disposable through the urban collection service arranged by the municipal authority.

Full bottles or containers (obsolete, stale products) shall be collected by the entity which marketed them, and shall be disposed of by the same as special waste.

The above information refers only to the use of cosmetic products specific for hairstyling activities.
