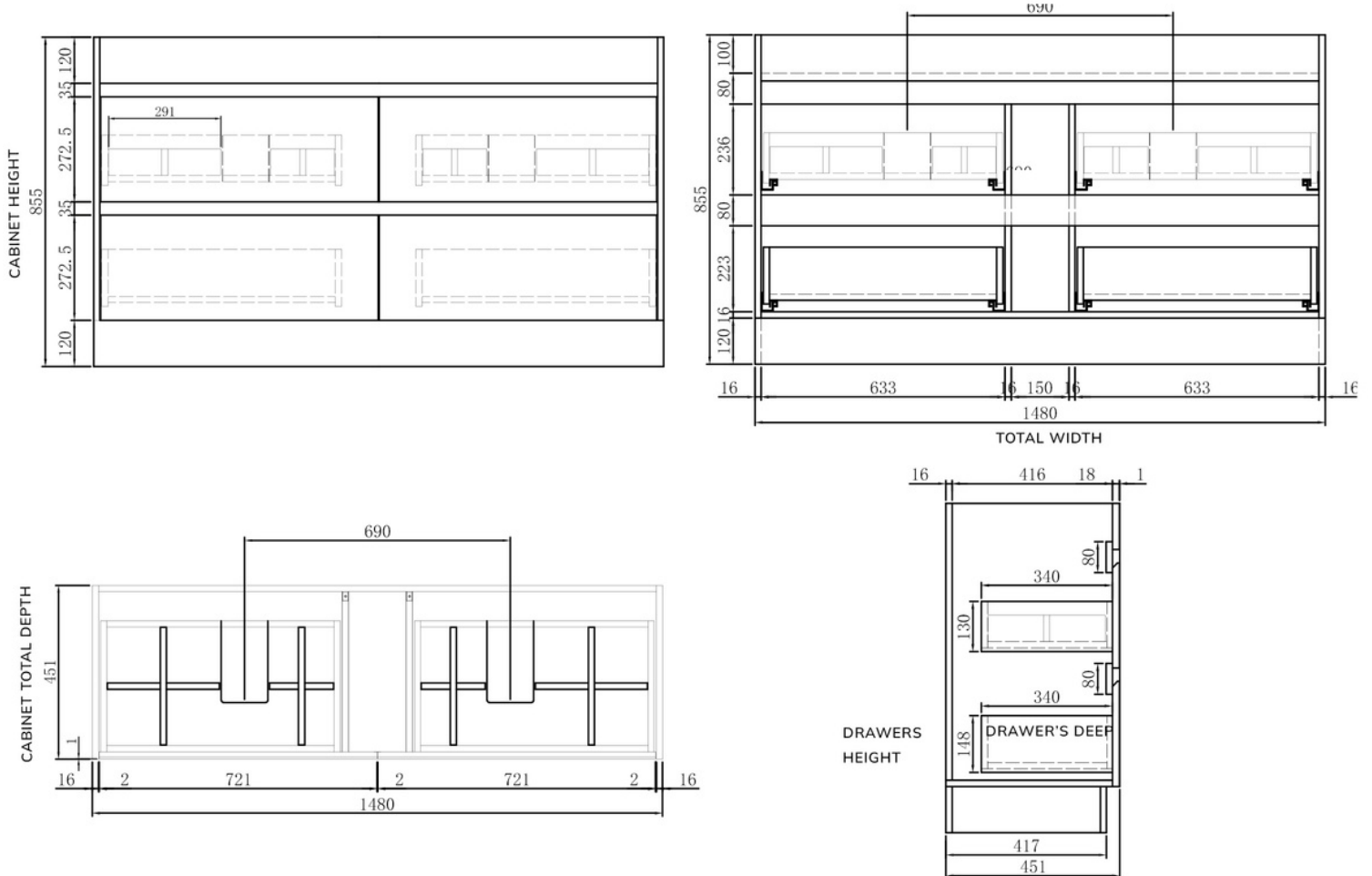

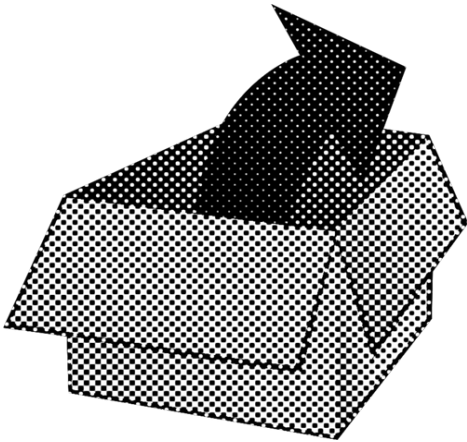

PLEASE NOTE: FIXING SCREWS/BOLTS ARE NOT SUPPLIED FOR INSTALLATION.

## CARE & MAINTENANCE

### CABINET

- USE A SOFT CLOTH AND A DILUTE SOLUTION OF NON-ABRASIVE DETERGENT TO MAINTAIN THE FINISH ON YOUR CABINET.
- RUB CAREFULLY WITH VEHICLE CUTTING COMPOUND, AUTO POLISH, OR DOMESTIC BRASS/SILVER CLEANER TO REMOVE SCRATCHES, MARKINGS, AND OTHER IMPERFECTIONS FROM TWO-PACK POLYURETHANE.
- ALL CABINETS SHOULD BE LOCATED AT LEAST 300MM AWAY FROM SHOWERS OR BATHTUBS TO AVOID WATER DAMAGE.
- GOODS USED IN CONSTRUCTION ARE WATER/MOISTURE-RESISTANT, BUT NOT WATER-PROOF.

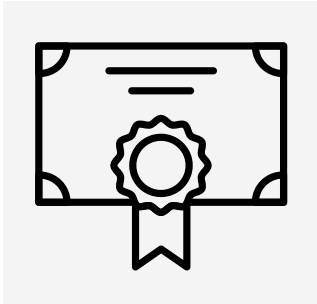
### CERAMIC BASINS AND TOPS

- USE A SOFT CLOTH AND A DILUTE SOLUTION OF NON-ABRASIVE DETERGENT TO MAINTAIN THE FINISH OF YOUR CERAMIC TOP.
- SCRATCHES ON CERAMIC TOPS CANNOT BE FIXED OR REMOVED DUE TO THE GLAZED SURFACE.
- SOME AESTHETIC DISTORTION MAY OCCUR BECAUSE CERAMIC IS A HANDCRAFTED PRODUCT THAT IS FIRED AT HIGH TEMPERATURES. THIS IS NOT A FLAW, BUT IT DOES ADD TO THE PRODUCT'S AESTHETIC APPEAL.

ALL PRODUCTS MUST BE INSTALLED BY A QUALIFIED TRADESPERSON.

IF THE PRODUCT IS NOT INSTALLED IN ACCORDANCE WITH THESE INSTRUCTIONS, YOUR LOUIS MARCO WARRANTY MAY BE VOID AND THE HOMEOWNER MAY HAVE A CLAIM AGAINST YOU (THE INSTALLER).

## WARRANTY



UNDER AUSTRALIAN CONSUMER LAW, OUR ITEMS ARE BACKED BY ASSURANCES THAT CANNOT BE REVOKED. IF A PRODUCT IS FOUND TO BE DEFECTIVE IN CONSTRUCTION, MATERIAL, OR ASSEMBLY, YOU ARE ENTITLED TO A REPLACEMENT OR REFUND AFTER AN INSPECTION BY AN AUTHORISED REPRESENTATIVE. IF THE ITEMS FAIL TO BE OF ACCEPTABLE QUALITY AND THE FAULT DOES NOT AMOUNT TO A MAJOR FAILURE, YOU HAVE THE RIGHT TO HAVE THEM REPAIRED OR REPLACED FOR FREE.
