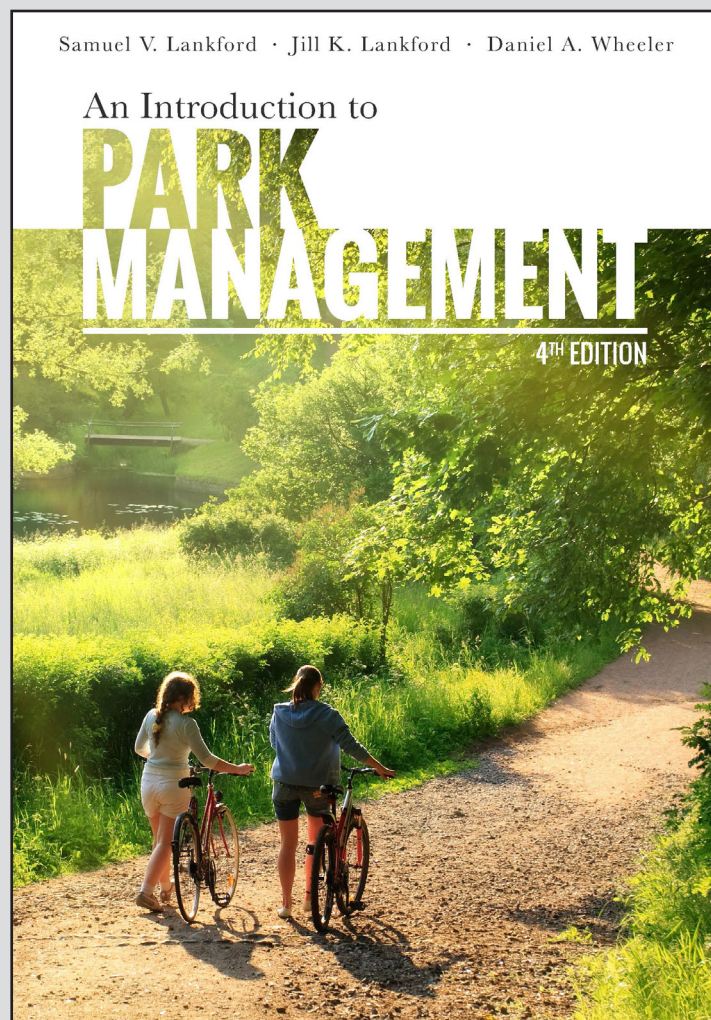

# 7

## Maintenance and Safety

### LEARNING OBJECTIVES

- Identify that park maintenance program are to keep the park environment clean, healthy, and safe and to conserve public monies by conscientious care of facilities and lands
- Identifying potential management concerns or issues before they become problematic
- Understanding the following factors affect the park's maintenance operation: type of visitor use, interpretation of areas, seasons of use, original design, latitude, altitude, labor relations, and environmental factors, such as weather, topography, soil type, and vegetative cover

# 8

## Citizen Participation and Involvement

### LEARNING OBJECTIVES

- Understand that citizens can be involved in park management by performing tasks under agency supervision, by participating in decision making through information input, or by belonging to a special interest group
- Identify that within a park agency, the person responsible for decision making must obtain advice from stakeholders. This can come from within the agency, from other agencies, and from private citizens or groups of citizens.
- Understand that citizens provide assistance in the decision-making process and play an important role in the implementation of decisions

## Park Facilities

### LEARNING OBJECTIVES

- Understand that facility location and design can also contribute to the degradation of the resource
- Give careful consideration to the location of every facility within a park to maximize use and control for user behaviors
- Understanding of facilities, their relationships, and their use is important to the design of new facilities or the remodel of existing facilities.
- Gain knowledge of the process used for facility design is critical to creating a visitor experience that complements park resources

## User Conflict Management

  - a. Reactive – Contact usually occurs after a crime or violation has been committed, and it is predominantly punitive in nature.
  - b. Proactive – contact usually occurs before a crime or violation has been committed, and it is predominantly preventative in nature.



# 15

## Fire Management

### LEARNING OBJECTIVES

- Understand that the protection of human lives, public property, and natural resources are still the responsibility of park managers during fires
- Utilize ability to plan for and be knowledgeable about the use of fire in managing park resources and understand the threat posed from surrounding lands
- Know the distinction between “controlled burns” and “wildfires.” Fire management includes fire prevention fire suppression
- Understand the use of fire for specified purposes, such as controlled burns or prescribed burning, wherein fire is used as a management tool

## Interpretation
