


QUICK - SETUP - GUIDE

QUICK - SETUP - GUIDE



Step 1 Remove the PCS-101 from its box and plug it into a standard US 120V electrical outlet that is close to the Squirrel Problem. Unfortunately, because of the vertical speaker, *this device is not waterproof*; please use a covered outlet that faces the most open area. The idea is to maximize the sound coverage, as soft objects can smother the sounds.

Step 2 Begin the three-stage process detailed below:

Stage 1 Slide the switch to **Mode A**. The **Red Light** will turn on, indicating that the PCS-101 is turned on & working. – Note: Mode A is the least audible mode for most people & household pets. –

Stage 2 On Day 4, slide the switch to **Mode B**. The Red Light will turn off and a **Green Light** will turn on.

Stage 3 On Day 7, slide the switch to **Mode C.** The **Green Light** will turn off and a **Blue Light** will turn on. – Note: Mode C is the most audible mode for most people & household pets. –

Step 3 CHANGE IS GOOD. After 10 days, return to Step 2 and repeat stages 1-3.

Cycling through the three stages changes which ultrasonic frequency ranges are being emitted, making it nearly impossible for squirrels to continue hanging around. **Step 4** The 16-20 day marks the turning point on what we do next. At this time, start to closely monitor to see if there is any more squirrel activity happening.

If you do not notice any new activity: Great! Your squirrel issue should be solved.

If there is still activity going on, then the next step is to Contact Us. We will help you make some changes to ensure your success.

SUMMARY

Squirrel issues will usually clear up within 14-16 days when repelling with the PCS101.
