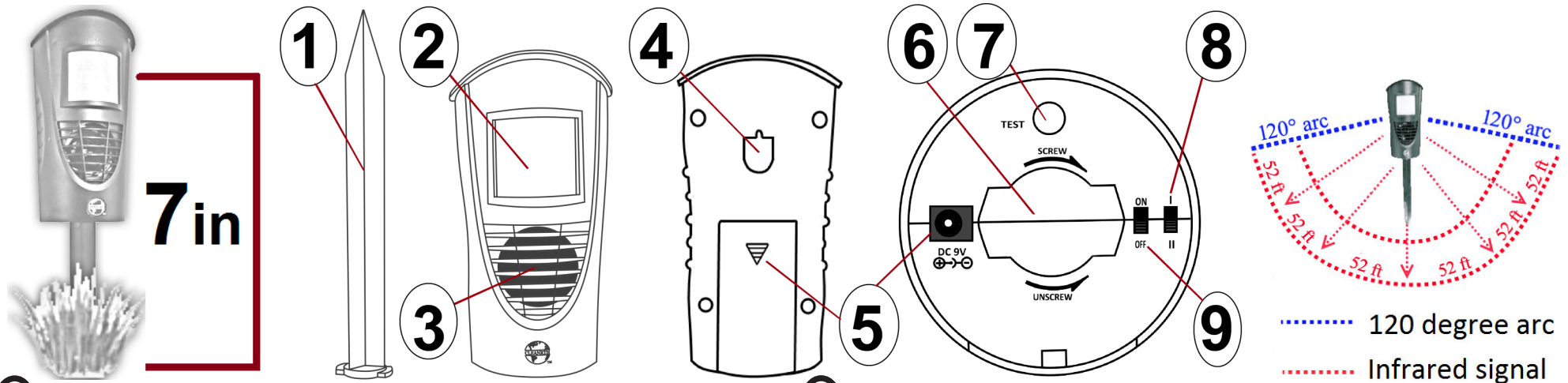

① Ground Stake: This 8.25inch Ground stake screws into the bottom of the unit as seen in the diagram above **Location 6**. For Best animal repelling performance when staking the device in the ground, you'll want the **Infrared Sensor** seen in **Location 2** to be **7 inches above ground or higher to maximize results.**

② Triple Scan Infrared Sensor: The motion infrared sensor has a three-layer lens for greater ability to detect warm body movement in a 120 degree arc field of view. The sensor reaches a distance of 52 feet, for approximately 2,000 square feet of unobstructed coverage.

③ High Intensity Speaker: The speaker emits ultrasonic sounds **dedicated to startling, scaring** and basically making the intruding animal as uncomfortable as possible. This trains the area and over time will fully keep out unwanted animals.

Helpful Hints: **Animals with-in the PIR Repelling Area Feel Uncomfortable / Disturbed.** **Animals outside the PIR Repelling Area will Feel Normal / Comfortable Again.**

④ Nail Mounts: You can use a nail or screw to hang the device from a wall or tree.

⑤ Power Source locations: Power the device by plugging the **power jack** into the bottom of the unit and the **adaptor** into a common US 120V electrical outlet (that is **protected from rain**) or by using two 9V alkaline batteries (not included).

⑥ Ground Spike Insert: Place the ground spike's flat end into the bottom of the base unit and twist clockwise to lock the spike into place or counter clockwise to unlock and remove the spike.

⑦ TEST BUTTON: This allows you to hear the TSAR520 at an Audible Level Indicating that the device is not broken. **ATTENTION!!! When the Test Button is On and you're hearing a Soft Buzzing Sound this device is Not Repelling.** **Please make sure the Test Button is Turned Off.**

- Test Button Sticking Out = Off.**
- Test Button Pressed In = On.**

⑧ High Intensity Ultrasonic Switch: **⑨ On/Off Switch:** These features create repelling change Turn unit on or off.
 -Mode I operates at a lower decibel range.
 -Mode II (**Recommended**) operates at a higher decibel range.

Running the Animal Repelling Routine & What To Expect

- 1) Once set up and repelling please allow **8 days** worth of repelling in one spot.
- 2) **Use the 8th day as a check point.** Do you still see animal activity on this day? Has the issue diminished at all? If the problem has improved, Great, please continue to use the device in its current settings.
- 3) If the animal problem **still heavily exists**, Please **Switch** from **Mode II to Mode I**. Additionally, feel free to reposition the device to a better location, if needed. **Change in repelling is Key to Animal Repelling Success!** After making these changes, please **allow another 8 days** of repelling.
- 4) **At this point** you should be **16 Days** in worth of repelling. **Has the issue diminished? If not!** Then its time for us to help. **Please Contact Us** and we will **move** to what we like to call our **Stage II** worth of help: **Free of Charge.**
