Joe Exotic to Pam Bondi; Trump Attorney General Nominee

Ms. Bondi,

Congratulations on your nomination to be President Trumps Attorney General of the United States of America.

I was sad to hear that Matt Gaetz withdrew because he was an avid supporter of my case and my innocence. However, I am excited to see you filling this position because of your background and being a woman. I will explain myself about that further into this letter.

In 2017-2018 the director of the Federal Fish and Wildlife Service- Dan Ash, along with one of his corrupt agents- Matthew Bryant waged a war against me to benefit Dan's position as president of the Association of Zoos and Aquariums and the Global Federation of Animal Sanctuaries (Carole Baskin).
