



Micro-shading Eyebrow Procedure

After Care Instructions

It is important to take the time to read and implement the aftercare instructions for safety and great healing results.

- **Day Two:** After the appointment, which is the next day after your procedure, you will apply a thin layer of ointment (A & D Ointment in the kit) twice a day, once in the morning and once at night. Please be sure to wash your hands then apply the ointment

with the brush applicator that is inside your kit.

- **Important to keep hands washed:** Keep hands away from the treated area. When applying any ointment or cleaning the treated area hands should be washed for 30 seconds.
- **Do not let the treated area get wet:** Avoid hot tubs, pools, recreational water activities or washing the treated areas. When in the shower, do not get the water directly on the face.
- **Do not expose treated area:** It is important for the area of the procedure not to encounter sweat, animals, direct shower spray or hot water.
- **During healing process:** Wear hat or visor when in the sun. It is important to keep the sun away from the treated area.
- **Makeup and lotions:** During the healing process, keep all makeup, lotions, and exfoliating products away from treated area.
- **Sleeping:** Avoid having your brows touch the pillow. This will help ensure the area treated will not be disturbed or encounter anything.
- **Tanning:** Avoid any tanning beds or direct sun.
- **What to expect during the healing process and protocol to follow:** The area of the procedure will begin to feel dry and chapped. DO NOT touch the area with anything other than the recommended ointment or cotton swabs. DO NOT pick at flaking skin. You may notice some flaking as the dead skin cells begin to slough off. This is normal and is to be expected. Eyebrow color goes through phases and may initially appear lighter, but within three to four weeks more color usually appears.
- **Long term care:** After the procedure has healed, begin an AM/PM regimen. For at least a month, use a hydrating moisturizer that is free of any anti-aging or anti-acne ingredients. Apply a 30 SPF sunscreen to the eyebrows to protect against premature fading.
- **Touch ups:** It is important to follow up with a touch appointment, if necessary, a month after the procedure. The touch ups are necessary to darken hair strokes that may have healed to light or adding additional ones where they are needed.
- **The following must be avoided during all 7 days post procedure:** Increased sweating – practicing sports – swimming – hot sauna, hot baths – lengthy showers – salon tanning – lasers – chemical peels – creams containing retinoids or acids
- **As the eyebrows began to flake, please do not pick, peel, or scratch the pigmented area. Let it naturally fall off.**
