Types of Emergencies

The EPP is based on three types of emergencies: natural (fire, flood, earthquake, hurricane, etc.); technological (utility outage, loss of services, hazardous materials spill, etc.); and man-made (active shooter, civil unrest, cyber-attack, etc.). The specific-procedures section guides managers in effective preparation for and execution of these procedures in such events.

Hazard Vulnerability Assessment

To commence the plan development process, a Hazard Vulnerability Analysis (HVA) tool has been provided for your use (see Appendix A). The HVA tool evaluates the variety of threats to people, facilities, operations, and infrastructure to determine those that are more likely to occur and to prioritize training for the occurrence of such events. This tool should be reviewed and an HVA completed prior to site-specific tailoring of the plan. The HVA will help identify what procedures are necessary, what situations could have the most significant impact on the facility, and where to focus on mitigation and training.

ICS (Incident Command System)

ICS is the model tool for command, control, and coordination of response and provides a means to coordinate the efforts of individual agencies as they work toward the common goal of stabilizing the incident and protecting life, property, and the environment. Regardless of the size of the incident or the number of agencies involved in the response, all incidents require a coordinated effort to ensure an effective response and the efficient, safe use of resources.
