Section 7 – OGL Company Policy

Rental Charges: Methods of computation:

The rental charge will be made on all cylinders held daily, and monthly billed.

The cylinders held by the customer at the beginning of the period will be shown on the invoice and cylinder movements will be shown with the monthly rental invoice.

Verification of cylinders:

Upon receipt of this invoice you are requested to verify the total number of cylinders held as at the date of invoice.

Where there is discrepancies notification is to be forwarded to our office within 14 days of receipt of this invoice, otherwise you will be held liable for the number of cylinders as shown.

No allowance will be made on any residual gas returned in the cylinders.

Deposits:

The company may charge a refundable cylinder deposit on all the cylinder/assets held and which will be returned to you when these are returned to OGL or our Agents.

A copy of the original invoice is required as proof for the refund of a deposit.

Customers are held responsible for all loss or damages to cylinders from whatever cause arising from the time of delivery until returned to the company and shall hold the company indemnified up to the agreed value of the cylinder for any loss, Destruction or Damage or Cost of Repair of Cylinder.

(Customers are advised to cover the cylinder by insurance)

Exchange or Swap Cylinders:

Exchange or swap cylinders shall at all times remain the property of OGL.

The rights of the Customer for any Exchange Cylinder cannot be assigned or transferred to a third party without the prior consent of Oceania Gas Limited,.

The Exchange Cylinders must not be filled until done so by Oceania Gas Limited.

Return Policy for hard good purchase - (anything within 7 days will be refunded)
Unutilized goods in original form.

Section 06– Title and Risk Policy

Oceania Gas Limited retains ownership of all goods supplied by OGL to the Customer until the Customer has paid for them and has paid other outstanding amounts due and payable to OGL.

Oceania Gas Limited shall take necessary legal security over the cylinders and any other good as allowed under the laws of this country.

Oceania Gas Limited Equipment:

Exchange Cylinders and gas containers remain at all times the absolute property of OGL and are supplied for the Customer's sole use.

The Customer will have no rights over any other property of Oceania Gas Limited or its contractors brought onto the Customer's site.

The risk for goods sold or supplied passes to the Customer upon delivery or collection.

Disclaimer to repossess the equipment owned by Oceania Gas Limited:

Oceania Gas Limited may enter upon the your Premises or any other premises on which OGL reasonably believes that the Equipment or cylinders needs to be repossessed may remove or open any obstruction or entrance and sever detach and dismantle the Equipment from the Premises or any vehicles land or property to which the equipment may have become affixed.

Upon repossession of the Equipment, OGL shall pay or credit to Customer's account the value of Customer's LPG in the Equipment.
