Applicant further agrees that Red Earth, Inc. and their respective agents and employees shall not be responsible in any way for (i) damage, loss or destruction of any property of applicant or (ii) injury to applicant or its representative, agency, employees, licensees or invitees.

In order to participate at the Red Earth Market, I acknowledge that I am in accordance with the Indian Arts and Crafts Act of 1990, Public Law 101-644 (104 Stat. 4662, Act of 11/29/90). I understand I may be asked to provide document of (1) proof of membership in a federally or state-recognized tribal entity; or (2) proof of certification as Indian Artisan by an Indian tribe.

In signing this agreement form I understand that all my sales at the Red Earth Fallfest Art Market are subject to an 8.675% sales tax. Artists, who do not have an Oklahoma Sales Tax Permit, must submit sales tax payment to Red Earth on Oct 15, 2022 prior to move-out. A tax form will be provided.

In signing this agreement, I do hereby agree and understand Red Earth, Inc. **will not issue refunds for booth or equipment fees paid. Event will be held "rain or shine"**. I have read the Fallfest Rules and Regulations and accept the terms as outlined.

RED EARTH FALLFEST ARTIST RULES & REGULATIONS

CAREFULLY READ the rules and regulations before submitting your application:

All work must be original, handcrafted, created, and exhibited by the approved artist themselves. Kits, imports, and commercial/mass-produced items are not allowed.

FIRST TIME ARTISTS: If you have not participated in a show or market with Red Earth submit the following information:

- Photos of the artwork you will be selling in your booth
- Copy of your tribal affiliation
- Booth fee may be made by check, money order or credit card.
- Application will not be accepted without payment.

RETURNING ARTISTS: If you have participated in a past Red Earth Festival or Market, Red Earth has a permanent file that includes your tribal membership card. Just complete the application and submit with your booth payment.

WEATHER: *This event will be held outdoors and will go on rain or shine.* No credits or refunds will be issued if show is affected by forces of nature beyond our control. Please note, we will not cancel Fallfest unless informed by state, city, or local officials that it will be in the best interest of safety for all.

NO SOLICITATION: Artists' role is to sell their work and not engage in any other non-related business activities during the event.

PROVIDED: Booths are 10 ft. by 10 ft. spaces. To keep the cost to a minimum, we encourage you to bring your own tent, chairs, and display equipment. Your booth fee also includes the required OKC Retail Sales permit for the day.

TENTS: Artists are responsible for making their tents sturdy against wind, rain etc. Tents **MUST** be manufactured of flame-retardant materials. The Myriad Gardens has an extensive sprinkler system. Therefore, staking into the ground or pavement will **NOT** be permitted. Sandbags should be used to stabilize your tent. Tents should be clean and in good working order. Sports team or commercial logos or sayings are not allowed.

SIGNAGE: We encourage signage with the name of the artist. Please **NO** Handwritten signs.

TRASH: The Myriad Gardens is a beautiful city park, and we ask you to leave your booth space clean when you leave. Please take your boxes and trash with you when you pack up. If your space is not clean after an event, it will affect your participation in future markets.

OKLAHOMA SALES TAXES: Artists are responsible for collecting Oklahoma Sales Tax at a rate of 8.675% and filing a report with the Oklahoma Tax Commission. If you do not have an Oklahoma Sales Tax Permit, you are required to provide your tax report and payment to Red Earth before moving-out.

RENTAL EQUIPMENT: If you would like to rent a 10x10 ft tent for this please notify Red Earth in advance for additional information. Contact the Red Earth office 405-427-5228.

ALL TENTS AND DISPLAYS MUST REMAIN WITHIN YOUR ASSIGNED 10 FT by 10 FT SPACE. PLEASE STORE EMPTY CONTAINERS AND BOXES IN YOUR VEHICLE OR UNDER TABLES.
