# Function Terms & Conditions



## 1. Deposit & Confirmation

- a. All functions are required to pay a deposit of \$200 to confirm the booking date.
- b. Full payment of food is to be paid & final confirmation of numbers is required no less than 5 days prior to the function date.
- c. Management reserves the right to cancel any booking where a deposit has not been paid.
- d. If your group is less than 20pp then a deposit may be required but there is no set menu or minimum spend.

## 2. Cancellation

- a. Deposits paid will be refunded at managements discretion up to 14 days prior to the function date.
- b. Management reserves the right to withhold any deposits paid if less than 14 days notice of cancellation is given.

## 3. Function Timing

- a. Start and finish times of all bookings must be confirmed 5 days prior to your function and approved by management.
- b. Departure times must be strictly adhered to. Management reserves the right to end any function at any given time they deem to be appropriate.

## 4. Menu / Beverage Selection

- a. Menu & beverage selections must be confirmed no less than 5 days before the function date.
- b. All food and beverage items are subject to change. If a selected item is not available the venue will find a suitable substitute.
- c. Final menu selection can be confirmed 2 weeks prior to your event.
- d. Note these are sample menus only and may be subject to change
- e. Our function menu options are designed for larger groups. If your booking is for 20 or more guests then you will need to choose one of these & a minimum food spend of \$20pp applies. Overall minimum spend does apply to exclusive use of an area and is set at the discretion of management.
- f. Drinks can be purchased on consumption or why not set up a tab! Set price bar packages are available on request.

## 5. Function Pricing

- a. The venue will do their best to ensure pricing at the time of your function is the same as when your booking was made, however please note that all pricing may be subject to change.
- b. All pricing is inclusive of GST.

## 6. Entertainment

- a. The venue reserves the right to approve all entertainment prior to the function. This includes bump in and bump out times of entertainers.

## 7. Outside Suppliers / Deliveries

- a. The venue accepts no responsibility for goods left on the premises before, after or during the function.
- b. All deliveries and their times for the function are to be pre approved by management.

## 8. Security

- a. If management deems that it is appropriate to have security at the function this cost will be added to the total function/event cost.

## 9. Liability

- a. The client/company shall be responsible in full for all costs/charges associated with the agreed reservations.
- b. The client/company shall be liable for any damages sustained to the venue by the client/company and guests, agents or any other person associated with the function.
- c. The venue and its employees or agents will not be liable for any damage, injury or loss of any nature, whether caused through negligence or not, suffered by the client/company or their guests, agents or for any other person associated with the function.

## 10. Unforeseen Circumstances

- a. However unlikely, if the venue is unable to comply with any provisions in this contract due to cessation or interruption of utilities, electric or gas supply, industrial disputes, plant or equipment failure, unavailability of goods, other unforeseen circumstances or accidents the venue reserves the right to cancel the booking and refund all deposits.
