### **REMOVAL OF FACTORY SPLASH GUARD**

Remove the clips and bolts to remove the factory plastic splash guard



# **RalliTEK SKID PLATE INSTALLATION**

2. Locate the threaded holes on the front sub-frame structure







3. Holding the skid plate and using the supplied 30mm long bolts, thread the bolts into the holes in the front subframe. Do not tighten yet.



4. Move to the rear of the skid plate and install the 50mm long bolts and nuts to the tabs on the transmission cross member. NOTE: Tighten the front bolts first and the rear bolts second.



5. Optional – Install 2 of the clips that held the factory splash guard into the remaining holes in the skid plate



# **OPTIONAL ACCESS PANEL INSTALLATION**

6. Insert the u-nuts onto the oil filter panel mounts as shown



7. Place the oil filter panel mounts on top of the opening on the skid plate, then thread in the button head fasteners to secure



8. Place the u-nuts on the oil drain panel mounts as shown




9. Pass the oil filter drain panel mounts through the skid plate as shown and secure to the plate with supplied button head fasteners



10. Install the oil filter and oil drain panels as shown using the supplied button head fasteners





#### WARRANTY

#### One Year Limited Warranty

**RalliTEK** warrants to the original purchaser that the parts manufactured and/or sold by RalliTEK (the Product) is free from defects in material and workmanship under normal use. RalliTEK warrants that the Product will per-form substantially in accordance with the specifications set forth in the documentation provided with it. The above express warranties are made for a period of the lesser of 12,000 miles or 12 months from the date the Product is installed in your vehicle.

Any improper use, operation beyond capacity, substitution of parts not approved by **RalliTEK** in writing, any alteration or repair by others, or any removal, defacing or altering of the identification shall void this warranty. There is no warranty on high-performance or race related parts due to the nature of usage.

The purchaser shall notify **RalliTEK** at 888-773-1212 of any defect within the warranty period no later than thirty (30) days after purchaser discovers the defect. Should any failure to conform to this warranty appear within the warranty period, RalliTEK shall, on notification, correct the nonconformity at its option, either by repairing any defective part, or by making available, FOB RalliTEK plant, a repaired or replacement part. The purchaser must insure any defective item being returned because RalliTEK does not assume risk of loss or damage while in transit. No payment or reimbursement shall be made for installation, removal, transportation or other charges. The remedies set forth in this instrument are exclusive, and the liability of RalliTEK with respect to any sale shall not exceed the price of the product on which the liability is based.
