

RALLITEK MINIMUM ADVERTISED PRICE (MAP)

RalliTEK Performance ("RalliTEK") prides itself on providing our customers with exceptional and innovative products that provide the highest value in the market. We realize our success is tied to the success of our distributors, dealers and resellers (hereafter referred to as "resellers"). We also realize many of our resellers invest considerable time, effort, and financial resources to provide their clients with a great customer experience. As such, we want to discourage price-based advertising that is detrimental to our resellers' continuing efforts. Therefore, RalliTEK is unilaterally implementing a Minimum Advertised Price (MAP) policy. The goal of this MAP policy is to protect and maintain both the actual and perceived value of RalliTEK products, while simultaneously supporting a fair and competitive environment for all our resellers, ultimately enabling them to provide an extraordinary customer experience.

• This policy applies to all RalliTEK products. RalliTEK may modify the products covered under this policy at any time.

• Advertising any RalliTEK product at less than **100%** of RalliTEK's MSRP ("List") price is a violation of this MAP policy.

• Advertising applies to all advertisements of MAP products in any and all media, including but not limited to: mailers, flyers, coupons, newspaper, radio, television, public signage, digital, electronic, and internet media in all forms including social media, apps, etc. Website features such as "click for price", automated "bounce-back" pricing emails, pre-formatted email responses, price display for items added to a cart, and similar advertisements are considered advertising under this MAP policy.

• This MAP policy applies to advertised prices, not the price at which MAP products are actually sold or offered for sale to an individual in-store or over the phone. This policy limits only the ability to advertise at a price lower than RalliTEK MAP.

• The inclusion of "free goods" with the purchase of RalliTEK's products is considered a MAP violation if the perceived value of the free good exceeds the difference between the selling price and the MAP.

• This MAP policy also applies to any activity which RalliTEK determines, in its sole discretion, is intended to circumvent the intent of this MAP policy.

• RalliTEK reserves the right to modify prices or this MAP policy at any time.

• From time to time, RalliTEK may permit resellers to advertise MAP products at prices lower than 100% of MSRP ("List"). In such events, RalliTEK may modify or suspend the MAP price for a specified period of time by providing advance notice to all resellers of such changes on our website or at <u>www.RalliTEK.com</u>.

• RalliTEK may authorizes generally accepted special advertising sales events when resellers may offer a discount of the RalliTEK MSRP ("List"). These events are TBD.

• RalliTEK will actively monitor and enforce this MAP policy. Violations may result in action being taken by RalliTEK, including: 1) Written and/or verbal notification of MAP violations with an accompanying request to correct the violation; 2) Suspension or adjustment of discounts including, but not limited to, advertising allowances/discounts built into RalliTEK pricing; 3) Refusal of purchase orders; 4) Removal of the right to use the RalliTEK logo and/or other intellectual property; 5) Termination of the business relationship with the violator.

Orders DO NOT always ship the same day of purchase. Please allow 48 hours for your order to ship.

DUTIES & TAXES

<u>RalliTEK does not pay any possible duties/taxes that may be required of the recipient outside of the</u> <u>United States.</u> The recipient is the importer of record and must comply with all laws and regulations of the destination country. Orders shipped outside of the US may be subject to import taxes, customs duties, and fees levied by the destination country. The recipient of an international shipment may be subject to such import taxes, customs duties, and fees, which are levied once a shipment reaches the recipient's country. Additional charges for customs clearance must be borne by the recipient; we have no control over these charges and can't predict what they may be.

Customs policies vary widely from country and providence. You should contact your local customs office for more information. When customs clearance procedures are required, it can cause delays beyond our original delivery estimates. If items are declined by the recipient during delivery as a failure to pay customs fees, the recipient will not be refunded if the items are not received back to RalliTEK and RalliTEK.com. If the items are received back, the recipient will be not be refunded shipping costs and will be charged a 25% restocking fee.

ORDERING PROCEDURE

RalliTEK and RalliTEK.com fulfill orders on a first-come, first-served basis. If the item you ordered is not in stock, you will be notified and we will fulfill your order as soon as possible. Cancellations at that time will not be subject to any cancellation fees. Some items on backorder take 4-6 weeks for delivery.

When you order a product, your credit card is charged immediately. You will begin to receive status update notifications about your order as it is prepared by our shipping staff.

When package(s) ship on your order, your order will be updated with tracking information. Once all items have been shipped, you will receive a final order status that all items have shipped. These statuses do not explain the packages associated with each tracking number.

ADDRESS CHANGES - DOES THIS APPLY TO WHOLESALERS?

For security reasons and fraud prevention, RalliTEK and RalliTEK.com will not change any shipping addresses on an order that has already been placed. The customer in question MUST replace the order with their correct credentials and request their incorrect order be canceled. At this time, any cancellation fees will be voided and the customer's incorrect order will be fully refunded.

PAYMENT TERMS

RalliTEK and RalliTEK.com accept ALL credit cards with appropriate billing and shipping addresses. RalliTEK and RalliTEK.com do not accept money orders or wire transfers. All orders must be completed online. Orders are to be paid in full at the time of purchase unless we contact you otherwise. On international orders, prices and shipping costs are subject to change anytime to reflect current exchange rates.

COVID-19 SHIPPING UPDATES

Please note that our products are delivered from various fulfillment centers. Certain products purchased during this time may be delayed due to business interruptions that are subject to local regulations regarding COVID-19. We do our best to estimate any potential delays in shipments on our product pages. We appreciate your patience and understanding at this time.

BACKORDERS

If your item is not in stock at the time of your order, you will be notified and we will fulfill your order as soon as possible. Some items on backorder take 4-6 weeks for delivery. Cancellations at this time will not be subject to cancellation fees.

CANCELLATION & RETURNS

Orders cannot be canceled once tracking numbers have been generated. A generated tracking number is established as soon as the shipping vendor has processed the package in their parcel tracking system. Please refer to the automated email or make contact with a RalliTEK representative for assistance locating a tracking number. Strut Assemblies cannot be cancelled once order is placed.

U.S. DOMESTIC CANCELLATIONS

If you order a product, your credit card is charged immediately. We will begin to receive notifications about your shipment as it is prepared by our shipping staff. If you choose to cancel the order the same day we received or not during business hours when the order has been processed, a 5% cancellation fee will be charged and the remaining amount will be credited back to you. Item changes prior to your order being shipped must be discussed with a RalliTEK employee.

U.S. DOMESTIC RETURNS

If a product is ordered and not wanted, the **unused**, **unopened** item can be returned for a 25% restocking fee. Shipping is not refundable in either direction. Items that are damaged and/or incorrect products received **must** be reported within 5 days of receiving the shipment to be considered for a return. No items will be returnable after 30 days.

INTERNATIONAL CANCELLATION & RETURNS

Due to the complexities and costs associated with international merchandise returns, all sales to our international customers are final. RalliTEK does not offer returns nor refunds for international addresses.

EXCHANGES

RalliTEK accepts exchanges but the original item must be received by RalliTEK in the very same condition it had been sold to avoid additional fees. To make a request for an exchange, customers must contact us by phone: **503-619-0055 EXT.2** or email: <u>dallin@rallitek.com</u> to receive approval and return instructions.

Terms for an Exchange:

- Customers must supply proof-of-purchase for the item before an exchange is considered. Customers are required to ship the original package at their own expense.
- In order to avoid a restocking fee, exchange items must arrive at our facility with all supporting parts and manuals and in the same **NEW** (pristine and re-sellable) condition in which it was sold.

• Items received in any other condition other than described above will incur a 25% restocking fee.

NON-DELIVERY & REFUSED DELIVERY

Orders returned to RalliTEK by the shipping carrier as "Undeliverable" or "Refused" will be refunded to the customer only after all freight charges and a 15% restocking fee are applied. If the customer desires to have the product resent to a new or corrected address, RalliTEK will charge the customer for the additional freight charges and waive the 15% restocking fee.

REFUNDS ON SHIPPING CHARGES

RalliTEK and RalliTEK.com does not refund shipping charges. In the event the product you ordered is sent or processed incorrectly by RalliTEK, we will accept the package back and credit the customer any additional shipping costs incurred by the error. If necessary, RalliTEK will reship the item back to the customer.

In the event a customer-provided address conflicts with the freight carrier and their ability to deliver a package, the customer is fully responsible for the product and the order charges. This includes shipping attempts to PO boxes or other delivery addresses that are not supported by the freight carrier. Customers must ensure they select the appropriate shipping address during online checkout with RalliTEK.

Only original, unaltered, and unmodified materials and workmanship are covered by this policy. This warranty does not cover damage caused by incorrect installation, accident, improper care, negligence, normal wear and tear, or the natural breakdown of colors and materials over extended time and use. Damage not covered under warranty may be repaired for a reasonable rate and a fee will be charged for return shipping.
