IFRA Category 1	Products applied to the lips: Lip products e.g. lipstick, lip balm; Childrens toys
IFRA Category 2	Products applied to the axillae: Deodorant and antiperspirant products of all types; Body sprays/mists
IFRA Category 3	Products applied to the face/body using fingertips: Eye products e.g. eye make-up, eye moisturizer; Facial make-up; Make-up remover; Nose pore strips; Wipes for face, neck, hands, body; Facial masks; Body and face paint
IFRA Category 4	Products related to fine fragrance: Hydroalcoholic and non-hydroalcoholic fine fragrance of all types e.g. Eau de Toilette, Parfum, Cologne, solid perfume, fragrancing cream, aftershaves of all types; Ingredients of perfume and fragrance mixtures for cosmetic kits; Scent pads; Scent strips
IFRA Category 5A	Body lotion products applied to the body using the hands (palms), primarily leave on: Foot care products e.g. creams, powders; Insect repellent for application to the skin; All powders and talc (excluding baby powders and talc)
IFRA Category 5B	Face moisturizer products applied to the face using the hands (palms), primarily leave on: Facial toner; Facial moisturizers and creams
IFRA Category 5C	Hand cream products applied to the hands using the hands (palms), primarily leave on: Hand cream; Nail care products including cuticle creams; Hand sanitizers
IFRA Category 5D	Baby creams, baby oils and baby talc: Baby cream/lotion, baby oil, baby powders and talc

IFRA Category 10A	<p>Household care excluding aerosol / spray products: Hand wash laundry detergent; Laundry pre-treatment of all types e.g. paste, sprays, sticks; Machine laundry detergents with skin contact e.g. liquids, powders; Fabric softeners of all types including fabric softener sheets; Ironing water; Hand dishwashing detergent; Hard surface cleaners of all types e.g. bathroom, kitchen cleansers, furniture polish; Toilet seat wipes; Household cleaning products, other types including fabric cleaners, carpet cleaners, furniture polishes sprays and wipes, stain removers, treatment products for textiles e.g. starch sprays; Floor wax; Dry cleaning kits; Fragranced oil for lamp ring, reed diffusers, pot-pourri, liquid refills for air fresheners (noncartridge systems), etc.</p>

IFRA Category 11A	<p>Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate without UV exposure: Feminine hygiene conventional pads, liners, interlabial pads; Diapers (baby and adult); Adult incontinence pant, pad; Toilet paper (dry)</p>
IFRA Category 11B	<p>Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate with potential UV exposure: Tights with moisturizers; Scented socks, gloves; Facial tissues (dry tissues); Napkins; Paper towels; Wheat bags; Facial masks (paper/protective) e.g. surgical masks not used as medical device; Fertilizers, solid (pellet or powder)</p>
