- 1. Definitions**
- 1.1 "Contract" means the terms and conditions contained herein, together with any Quotation, order, invoice or other document or amendments expressed to be supplemental to this Contract.
- 1.2 "Pozitive" means Positive Camtec Pty Ltd T/A Pozitive Sign & Graphic Supplies, its successors and assigns or any person acting on behalf of and with the authority of Positive Camtec Pty Ltd T/A Pozitive Sign & Graphic Supplies.
- 1.3 "Client" means the person/s, entities or any person acting on behalf of and with the authority of the Client requesting Pozitive to provide the Services as specified in any proposal, quotation, order, invoice or other documentation, and:
- (a) if there is more than one Client, is a reference to each Client jointly and severally; and
- (b) if the Client is a partnership, it shall bind each partner jointly and severally; and
- (c) if the Client is a part of a Trust, shall be bound in their capacity as a trustee; and
- (d) includes the Client's executors, administrators, successors and permitted assigns.
- 1.4 "Goods" means all Goods or Services supplied by Pozitive to the Client at the Client's request from time to time (where the context so permits the terms 'Goods' or 'Services' shall be interchangeable for the other).
- 1.5 "Confidential Information" means information of a confidential nature whether oral, written or in electronic form including, but not limited to, this Contract, either party's intellectual property, operational information, know-how, trade secrets, financial and commercial affairs, contracts, client information (including but not limited to, "Personal Information" such as: name, address, D.O.B, occupation, driver's license details, electronic contact (email, Facebook or Twitter details), medical insurance details or next of kin and other contact information (where applicable), previous credit applications, credit history) and pricing details.
- 1.6 "Cookies" means small files which are stored on a user's computer. They are designed to hold a modest amount of data (including personal information) specific to a particular client and website, and can be accessed either by the web server or the client's computer. **If the Client does not wish to allow Cookies to operate in the background when ordering from the website, then the Client shall have the right to enable / disable the Cookies first by selecting the option to enable / disable provided on the website, prior to ordering Goods via the website.**
- 1.7 "Price" means the Price payable (plus any GST where applicable) for the Goods as agreed between Pozitive and the Client in accordance with clause 5 below.
- 1.8 "GST" means Goods and Services Tax as defined within the "A New Tax System (Goods and Services Tax) Act 1999" (Ch).
- 2. Acceptance**
- 2.1 The Client is taken to have exclusively accepted and is immediately bound, jointly and severally, by these terms and conditions if the Client places an order for or accepts delivery of the Goods.
- 2.2 In the event of any inconsistency between the terms and conditions of this Contract and any other prior document or schedule that the parties have entered into, the terms of this Contract shall prevail.
- 2.3 Any amendment to the terms and conditions contained in this Contract may only be amended in writing by the consent of both parties.
- 2.4 The Client acknowledges that the supply of Goods on credit shall not take effect until the Client has completed a credit application with Pozitive and it has been approved with a credit limit established for the account.
- 2.5 In the event that the supply of Goods request exceeds the Client's credit limit and/or the account exceeds the payment terms, Pozitive reserves the right to refuse delivery and/or request an alternative payment method.
- 2.6 Pozitive reserves the right to accept any order in whole or in part or to refuse any order.
- 2.7 Any (and all) Goods are offered for sale on a supply only basis, unless specified otherwise in writing, and is not sold under a franchise agreement or implied franchise agreement.
- 2.8 It is the responsibility of the Client to independently determine the suitability of the Goods for intended purpose and usage before placing an order for the Goods. Pozitive shall not be liable in any way whatsoever should the Client choose not to comply with this clause.
- 2.9 Electronic signatures shall be deemed to be accepted by either party providing that the parties have complied with Section 9 of the Electronic Transactions Act 2000 or any other applicable provisions of that Act or any Regulations referred to in that Act.
- 3. Errors and Omissions**
- 3.1 The Client acknowledges and accepts that Pozitive shall, without prejudice, accept no liability in respect of any alleged or actual error(s) and/or omission(s):
- (a) resulting from an inadvertent mistake made by Pozitive in the formation and/or administration of this Contract; and/or
- (b) contained in/omitted from any literature (hard copy and/or electronic) supplied by Pozitive in respect of the Services.
- 3.2 In the event such an error and/or omission occurs in accordance with clause 3.1, and is not attributable to the negligence and/or wilful misconduct of Pozitive; the Client shall not be entitled to treat this Contract as repudiated nor render it invalid.
- 4. Change in Control**
- 4.1 The Client shall give Pozitive not less than fourteen (14) days prior written notice of any proposed change of ownership of the Client and/or any other change in the Client's details (including but not limited to, changes in the Client's name, address, contact phone or fax number/s, change of trustees or business practice). The Client shall be liable for any loss incurred by Pozitive as a result of the Client's failure to comply with this clause.
- 5. Price and Payment**
- 5.1 At Pozitive's sole discretion, the Price shall be either:
- (a) as indicated on any invoice provided by Pozitive to the Client; or
- (b) the Price as at the date of delivery of the Goods according to Pozitive's current price list; or
- (c) Pozitive's quoted price (subject to clause 5.2) which will be valid for the period stated in the quotation or otherwise for a period of thirty (30) days.
- 5.2 Pozitive reserves the right to change the Price if a variation to Pozitive's quotation is requested. Any variation from the plan of scheduled Services or specifications of the Goods (including, but not limited to, any variation as a result of fluctuations in currency exchange rates or increases to Pozitive in the cost of taxes, levies, freight and insurance charges, materials and labour or delays in shipment etc.) will be charged for on the basis of Pozitive's quotation, and will be detailed in writing, and shown as variations on Pozitive's invoice. The Client shall be required to respond to any variation submitted by Pozitive within ten (10) working days. Failure to do so will entitle Pozitive to add the cost of the variation to the Price. Payment for all variations must be made in full at the time of their completion.
- 5.3 At Pozitive's sole discretion, a deposit may be required. The deposit amount or percentage of the Price due will be stipulated at the time of the order of the Goods and/or Services and shall become immediately due and payable.
- 5.4 Time for payment for the Goods being of the essence, the Price will be payable by the Client on the date/s determined by Pozitive, which may be:
- (a) on delivery of the Goods;
- (b) before delivery of the Goods;
- (c) thirty (30) days following the end of the month in which a statement is posted to the Client's address or address for notices;
- (d) the date specified on any invoice or other form as being the date for payment; or
- (e) failing any notice to the contrary, the date which is seven (7) days following the date of any invoice given to the Client by Pozitive.
- 5.5 Payment may be made by cash, cheque, bank cheque, electronic/on-line banking, credit card (a surcharge may apply per transaction), or by any other method as agreed to between the Client and Pozitive.
- 5.6 Pozitive may in its discretion allocate any payment received from the Client towards any invoice that Pozitive determines and may do so at the time of receipt or at any time afterwards. On any default by the Client Pozitive may re-allocate any payments previously received and allocated. In the absence of any payment allocation by Pozitive, payment will be deemed to be allocated in such manner as preserves the maximum value of Pozitive's Purchase Money Security Interest (as defined in the PPSA) in the Goods.
- 5.7 The Client shall not be entitled to set off against, or deduct from the Price, any sums owed or claimed to be owed to the Client by Pozitive nor to withhold payment of any invoice because part of that invoice is in dispute.

- 10.3 Where Goods are supplied on consignment the following provisions apply specifically to those Goods:
- (a) the Goods shall be at the Client's risk from the time of delivery and the Client shall be responsible for insuring the Goods. The Goods must be covered by insurance against fire, theft or malicious damage to the value of the purchase price and is the responsibility of the Client;
- (b) all accessories, consumables and software supplied to the Client at the point of consignment must remain intact and returned with the Goods. Any accessories, consumables and software not returned in a saleable condition will be invoiced to the Client at normal rates and must be paid within Pozitive's normal trading terms as per clause 5.4.
- (c) all original packaging must be maintained and returned in a satisfactory condition;
- (d) the Client may retain possession of the Goods until the Client sells them or Pozitive requires re-delivery of them to Pozitive, whichever first occurs;
- (e) freight for the units consigned will be charged to the Client's account unless an alternative arrangement is made between Pozitive or its representative;
- (f) if Pozitive requires re-delivery of the Goods such re-delivery shall be at the Client's cost.
- 10.4 Notwithstanding clause 10.3 the Client agrees to retain an accurate schedule of the Goods sold on a monthly basis and agrees to replace Goods sold each month to maintain the agreed consignment Goods levels. Pozitive reserves the right to carry out an annual stock take and the Client agrees to indemnify Pozitive in the event of any discrepancies in the schedule of consignment Goods held on site.
- 10.5 The Client further agrees that:
- (a) Pozitive have the right to inspect the consignment Goods at any time upon giving written notice to the Client; and
- (b) Pozitive reserves the right to cease the supply of consignment Goods and enforce clause 10.3(b) if upon inspection it is found the consignment Goods
- total do not correspond with information supplied by the Client and/or the consignment Goods are not stored in accordance with Pozitive's instructions; and
- (c) consignment Goods shall be placed on display at front of house together with any advertising material supplied by Pozitive to the Client; and
- (d) the stand for consignment Goods are to be kept stocked to the agreed minimum levels at all times; and
- (e) the Client is responsible for the upkeep of the stand and agrees to take all due care to ensure that the consignment Goods are not damaged or marked in any way; and
- (f) they shall immediately advise Pozitive if for any reason they opt to remove the consignment Goods from display area.
- 11. Title**
- 11.1 Pozitive and the Client agree that ownership of the Goods shall not pass until:
- (a) the Client has paid Pozitive all amounts owing to Pozitive; and
- (b) the Client has met all of its other obligations to Pozitive.
- 11.2 Receipt by Pozitive of any form of payment other than cash shall not be deemed to be payment until that form of payment has been honoured, cleared or recognised.
- 11.3 It is further agreed that, until ownership of the Goods passes to the Client in accordance with clause 11.1:
- (a) the Client is only a bailee of the Goods and must return the Goods to Pozitive on request;
- (b) the Client holds the benefit of the Client's insurance of the Goods on trust for Pozitive and must pay to Pozitive the proceeds of any insurance in the event of the Goods being lost, damaged or destroyed;
- (c) the Client must not sell, dispose, or otherwise part with possession of the Goods other than in the ordinary course of business and for market value. If the Client sells, disposes or parts with possession of the Goods then the Client must hold the proceeds of any such act on trust for Pozitive and must pay or deliver the proceeds to Pozitive on demand;
- (d) the Client should not convert or process the Goods or intermix them with other goods but if the Client does so then the Client holds the resulting product on trust for the benefit of Pozitive and must sell, dispose of or return the resulting product to Pozitive as it so directs;
- (e) the Client irrevocably authorises Pozitive to enter any premises where Pozitive believes the Goods are kept and recover possession of the Goods;
- (f) Pozitive may recover possession of any Goods in transit whether or not delivery has occurred;
- (g) the Client shall not charge or grant an encumbrance over the Goods nor grant nor otherwise give away any interest in the Goods while they remain the property of Pozitive;
- (h) Pozitive may commence proceedings to recover the Price of the Goods sold notwithstanding that ownership of the Goods has not passed to the Client.
- 12. Personal Property Securities Act 2009 ("PPSA")**
- 12.1 In this clause financing statement, financing change statement, security agreement, and security interest has the meaning given to it by the PPSA.
- 12.2 Upon assenting to these terms and conditions in writing the Client acknowledges and agrees that these terms and conditions constitute a security agreement for the purposes of the PPSA and creates a security interest in all Goods and/or collateral (account) – being a monetary obligation of the Client to Pozitive for Services – that have previously been supplied and that will be supplied in the future by Pozitive to the Client.
- 12.3 The Client undertakes to:
- (a) promptly sign any further documents and/or provide any further information (such information to be complete, accurate and up-to-date in all respects) which Pozitive may reasonably require to:
- (i) register a financing statement or financing change statement in relation to a security interest on the Personal Property Securities Register;
- (ii) register any other document required to be registered by the PPSA; or
- (iii) correct a defect in a statement referred to in clause 12.3(a)(i) or 12.3(a)(ii);
- (b) indemnify, and upon demand reimburse, Pozitive for all expenses incurred in registering a financing statement or financing change statement on the Personal Property Securities Register established by the PPSA or releasing any Goods charged thereby;
- (c) not register a financing change statement in respect of a security interest without the prior written consent of Pozitive;
- (d) not register, or permit to be registered, a financing statement or a financing change statement in relation to the Goods and/or collateral (account) in favour of a third party without the prior written consent of Pozitive;
- (e) immediately advise Pozitive of any material change in its business practices of selling the Goods which would result in a change in the nature of proceeds derived from such sales.
- 12.4 Pozitive and the Client agree that sections 96, 115 and 125 of the PPSA do not apply to the security agreement created by these terms and conditions.
- 12.5 The Client waives their rights to receive notices under sections 95, 118, 121(4), 130, 132(3)(d) and 132(4) of the PPSA.
- 12.6 The Client waives their rights as a grantor and/or a debtor under sections 142 and 143 of the PPSA.
- 12.7 Unless otherwise agreed to in writing by Pozitive, the Client waives their right to receive a verification statement in accordance with section 157 of the PPSA.
- 12.8 The Client must unconditionally ratify any actions taken by Pozitive under clauses 12.3 to 12.5.

- 12.9 Subject to any express provisions to the contrary (including those contained in this clause 12), nothing in these terms and conditions is intended to have the effect of contracting out of any of the provisions of the PPSA.
- 13. Security and Charge**  
 13.1 In consideration of Pozitive agreeing to supply the Goods, the Client charges all of its rights, title and interest (whether joint or several) in any land, realty or other assets capable of being charged, owned by the Client either now or in the future, to secure the performance by the Client of its obligations under these terms and conditions (including, but not limited to, the payment of any money).
- 13.2 The Client indemnifies Pozitive from and against all Pozitive's costs and disbursements including legal costs on a solicitor and own client basis incurred in exercising Pozitive's rights under this clause.
- 13.3 The Client irrevocably appoints Pozitive and each director of Pozitive as the Client's true and lawful attorney/s to perform all necessary acts to give effect to the provisions of this clause 13 including, but not limited to, signing any document on the Client's behalf.
- 14. Defects, Warranties and Returns, Competition and Consumer Act 2010 (CCA)**  
 14.1 The Client must inspect the Goods on delivery and must within seven (7) days of delivery notify Pozitive in writing of any evident defect/damage, shortage in quantity, or failure to comply with the description or quote. The Client must notify any other alleged defect in the Goods as soon as reasonably possible after any such defect becomes evident. Upon such notification the Client must allow Pozitive to inspect the Goods.
- 14.2 Under applicable State, Territory and Commonwealth Law (including, without limitation the CCA), certain statutory implied guarantees and warranties (including, without limitation the statutory guarantees under the CCA) may be implied into these terms and conditions (**Non-Excluded Guarantees**).
- 14.3 Pozitive acknowledges that nothing in these terms and conditions purports to modify or exclude the Non-Excluded Guarantees.
- 14.4 Except as expressly set out in these terms and conditions or in respect of the Non-Excluded Guarantees, Pozitive makes no warranties or other representations under these terms and conditions including but not limited to the quality or suitability of the Goods. Pozitive's liability in respect of these warranties is limited to the fullest extent permitted by law.
- 14.5 If the Client is a consumer within the meaning of the CCA, Pozitive's liability is limited to the extent permitted by section 64A of Schedule 2.
- 14.6 If Pozitive is required to replace the Goods under this clause or the CCA, but is unable to do so, Pozitive may refund any money the Client has paid for the Goods.
- 14.7 If the Client is not a consumer within the meaning of the CCA, Pozitive's liability for any defect or damage in the Goods is:  
 (a) limited to the value of any express warranty or warranty card provided to the Client by Pozitive at Pozitive's sole discretion;  
 (b) limited to any warranty to which Pozitive is entitled, if Pozitive did not manufacture the Goods;  
 (c) otherwise negated absolutely.
- 14.8 Subject to this clause 14, returns will only be accepted provided that:  
 (a) the Client has complied with the provisions of clause 14.1; and  
 (b) Pozitive has agreed that the Goods are defective; and  
 (c) the Goods are returned within a reasonable time at the Client's cost (if that cost is not significant); and  
 (d) the Goods are returned in as close a condition to that in which they were delivered as is possible.
- 14.9 Notwithstanding clauses 14.1 to 14.8 but subject to the CCA, Pozitive shall not be liable for any defect or damage which may be caused or partly caused by or arise as a result of:  
 (a) the Client failing to properly maintain or store any Goods;  
 (b) the Client using the Goods for any purpose other than that for which they were designed;  
 (c) the Client continuing the use of any Goods after any defect became apparent or should have become apparent to a reasonably prudent operator or user;  
 (d) the Client failing to follow any instructions or guidelines provided by Pozitive;  
 (e) fair wear and tear, any accident, or act of God.
- 14.10 In the case of second hand Goods, unless the Client is a consumer under the CCA, the Client acknowledges that it has had full opportunity to inspect the second hand Goods prior to delivery and accepts them with all faults and that to the extent permitted by law no warranty is given by Pozitive as to the quality or suitability for any purpose and any implied warranty, statutory or otherwise, is expressly excluded. The Client acknowledges and agrees that Pozitive has agreed to provide the Client with the second hand Goods and calculated the Price of the second hand Goods in reliance of this clause 14.10.
- 14.11 Pozitive may in its absolute discretion accept non-defective Goods for return in which case Pozitive may require the Client to pay handling fees of up to twenty-five percent (25%) of the value of the returned Goods plus any freight costs.
- 14.12 Notwithstanding anything contained in this clause if Pozitive is required by a law to accept a return then Pozitive will only accept a return on the conditions imposed by that law.
- 14.13 Subject to clause 14.1, customised, or non-stocklist items or Goods made or ordered to the Client's specifications are not acceptable for credit or return.
- 15. Intellectual Property**  
 15.1 Where Pozitive has designed, drawn or developed Goods for the Client, then the copyright in any designs and drawings and documents shall remain the property of Pozitive. Under no circumstances may such designs, drawings and documents be used without the express written approval of Pozitive.
- 15.2 The Client warrants that all designs, specifications or instructions given to Pozitive will not cause Pozitive to infringe any patent, registered design or trademark in the execution of the Client's order and the Client agrees to indemnify Pozitive against any action taken by a third party against Pozitive in respect of any such infringement.
- 15.3 The Client agrees that Pozitive may (at no cost) use for the purposes of marketing or entry into any competition, any documents, designs, drawings or Goods which Pozitive has created for the Client.
- 16. Default and Consequences of Default**  
 16.1 Interest on overdue invoices shall accrue daily from the date when payment becomes due, until the date of payment, at a rate of two and a half percent (2.5%) per calendar month (and at Pozitive's sole discretion such interest shall compound monthly at such a rate) after as well as before any judgment.
- 16.2 If the Client owes Pozitive any money the Client shall indemnify Pozitive from and against all costs and disbursements incurred by Pozitive in recovering the debt (including but not limited to internal administration fees, legal costs on a solicitor and own client basis, Pozitive's contract default fee, and bank disbursement fees).
- 16.3 Further to any other rights or remedies Pozitive may have under this Contract, if a Client has made payment to Pozitive, and the transaction is subsequently reversed, the Client shall be liable for the amount of the reversed transaction, in addition to any further costs incurred by Pozitive under this clause 16 where it can be proven that such reversal is found to be illegal, fraudulent or in contravention to the Client's obligations under this Contract.
- 16.4 Without prejudice to Pozitive's other remedies at law Pozitive shall be entitled to cancel all or any part of any order of the Client which remains unfulfilled and all amounts owing to Pozitive shall, whether or not due for payment, become immediately payable if:  
 (a) any money payable to Pozitive becomes overdue, or in Pozitive's opinion the Client will be unable to make a payment when it falls due;  
 (b) the Client has exceeded any applicable credit limit provided by Pozitive;  
 (c) the Client becomes insolvent, convenes a meeting with its creditors or proposes or enters into an arrangement with creditors, or makes an assignment for the benefit of its creditors; or  
 (d) a receiver, manager, liquidator (provisional or otherwise) or similar person is appointed in respect of the Client or any asset of the Client.
- 17. Cancellation**  
 17.1 Without prejudice to any other remedies Pozitive may have, if at any time the Client is in breach of any obligation (including those relating to payment) under these terms and conditions Pozitive may suspend or terminate the supply of Goods to the Client. Pozitive will not be liable to the Client for any loss or damage the Client suffers because Pozitive has exercised its rights under this clause.
- 17.2 Pozitive may cancel any Contract to which these terms and conditions apply or cancel delivery of Goods at any time before the Goods are delivered by giving written notice to the Client. On giving such notice Pozitive shall repay to the Client any money paid by the Client for the Goods. Pozitive shall not be liable for any loss or damage whatsoever arising from such cancellation.
- 17.3 In the event that the Client cancels delivery of Goods the Client shall be liable for any and all loss incurred (whether direct or indirect) by Pozitive as a direct result of the cancellation (including, but not limited to, any loss of profits).
- 17.4 Cancellation of orders for Goods made to the Client's specifications, or for non-stocklist items, will definitely not be accepted once production has commenced, or an order has been placed.
- 18. Privacy Policy**  
 18.1 All emails, documents, images or other recorded information held or used by Pozitive is Personal Information, as defined and referred to in clause 18.3, and therefore considered Confidential Information. Pozitive acknowledges its obligation in relation to the handling, use, disclosure and processing of Personal Information pursuant to the Privacy Act 1988 ("the Act") including the Part IIC of the Act being Privacy Amendment (Notifiable Data Breaches) Act 2017 (NDB) and any statutory requirements, where relevant in a European Economic Area ("EEA"), under the EU Data Privacy Laws (including the General Data Protection Regulation "GDPR") (collectively, "EU Data Privacy Laws"). Pozitive acknowledges that in the event it becomes aware of any data breaches and/or disclosure of the Client's Personal Information, held by Pozitive that may result in serious harm to the Client, Pozitive will notify the Client in accordance with the Act and/or the GDPR. Any release of such personal information must be in accordance with the Act and the GDPR (where relevant) and must be approved by the Client by written consent, unless subject to an operation of law.
- 18.2 Notwithstanding clause 18.1, privacy limitations will extend to Pozitive in respect of Cookies where transactions for purchases/orders transpire directly from Pozitive's website. Pozitive agrees to display reference to such Cookies and/or similar tracking technologies, such as pixels and web beacons (if applicable), such technology allows the collection of Personal Information such as the Client's:  
 (a) IP address, browser, email client type and other similar details;  
 (b) tracking website usage and traffic; and  
 (c) reports are available to Pozitive when Pozitive sends an email to the Client, so Pozitive may collect and review that information ("collectively Personal Information")
- In order to enable / disable the collection of Personal Information by way of Cookies, the Client shall have the right to enable / disable the Cookies first by selecting the option to enable / disable, provided on the website prior to proceeding with a purchase/order via Pozitive's website.
- 18.3 The Client agrees for Pozitive to obtain from a credit reporting body (CRB) a credit report containing personal credit information (e.g. name, address, D.O.B, occupation, driver's license details, electronic contact (email, Facebook or Twitter details), medical insurance details or next of kin and other contact information (where applicable), previous credit applications, credit history) about the Client in relation to credit provided by Pozitive.
- 18.4 The Client agrees that Pozitive may exchange information about the Client with those credit providers and with related body corporates for the following purposes:  
 (a) to assess an application by the Client; and/or  
 (b) to notify other credit providers of a default by the Client; and/or  
 (c) to exchange information with other credit providers as to the status of this credit account, where the Client is in default with other credit providers; and/or  
 (d) to assess the creditworthiness of the Client including the Client's repayment history in the preceding two (2) years.
- 18.5 The Client consents to Pozitive being given a consumer credit report to collect overdue payment on commercial credit.
- 18.6 The Client agrees that personal credit information provided may be used and retained by Pozitive for the following purposes (and for other agreed purposes or required by):  
 (a) the provision of Goods; and/or  
 (b) analysing, verifying and/or checking the Client's credit, payment and/or status in relation to the provision of Goods; and/or  
 (c) processing of any payment instructions, direct debit facilities and/or credit facilities requested by the Client; and/or  
 (d) enabling the collection of amounts outstanding in relation to the Goods.
- 18.7 Pozitive may give information about the Client to a CRB for the following purposes:  
 (a) to obtain a consumer credit report;  
 (b) allow the CRB to create or maintain a credit information file about the Client including credit history.
- 18.8 The information given to the CRB may include:  
 (a) Personal Information as outlined in 18.1 above;  
 (b) name of the credit provider and that Pozitive is a current credit provider to the Client;  
 (c) whether the credit provider is a licensee;  
 (d) type of consumer credit;  
 (e) details concerning the Client's application for credit or commercial credit (e.g. date of commencement/termination of the credit account and the amount requested);  
 (f) advice of consumer credit defaults, overdue accounts, loan repayments or outstanding monies which are overdue by more than sixty (60) days and for which written notice for request of payment has been made and debt recovery action commenced or alternatively that the Client no longer has any overdue accounts and Pozitive has been paid or otherwise discharged and all details surrounding that discharge (e.g. dates of payments);  
 (g) information that, in the opinion of Pozitive, the Client has committed a serious credit infringement; advice that the amount of the Client's overdue payment is equal to or more than one hundred and fifty dollars (\$150).
- 18.9 The Client shall have the right to request (by e-mail) from Pozitive:  
 (a) a copy of the Personal Information about the Client retained by Pozitive and the right to request that Pozitive correct any incorrect Personal Information; and  
 (b) that Pozitive does not disclose any personal information about the Client for the purpose of direct marketing.
- 18.10 Pozitive will destroy personal information upon the Client's request (by e-mail) or if it is no longer required unless it is required in order to fulfil the obligations of this Contract or is required to be maintained and/or stored in accordance with the law.
- 18.11 The Client can make a privacy complaint by contacting Pozitive via e-mail. Pozitive will respond to that complaint within seven (7) days of receipt and will take all reasonable steps to make a decision as to the complaint within thirty (30) days of receipt of the complaint. In the event that the Client is not satisfied with the resolution provided, the Client can make a complaint to the Information Commissioner at [www.oaic.gov.au](http://www.oaic.gov.au).
- 19. Dispute Resolution**  
 19.1 If a dispute arises between the parties to this Contract, then either party shall send to the other party a notice of dispute in writing adequately identifying and providing details of the dispute. Within fourteen (14) days after service of a notice of dispute, the parties shall confer at least once, to attempt to resolve the dispute. At any such conference each party shall be represented by a person having authority to agree to a resolution of the dispute. In the event that the dispute cannot be so resolved either party may by further notice in writing delivered by hand or sent by certified mail to the other party refer such dispute to arbitration. Any arbitration shall be:  
 (a) referred to a single arbitrator to be nominated by the President of the Institute of Arbitrators Australia; and  
 (b) conducted in accordance with the Institute of Arbitrators Australia Rules for the Conduct of Commercial Arbitration.
- 20. Unpaid Seller's Rights**  
 20.1 Where the Client has left any item with Pozitive for repair, modification, exchange or for Pozitive to perform any other service in relation to the item and Pozitive has not received or been tendered the whole of any monies owing to it by the Client, Pozitive shall have, until all monies owing to Pozitive are paid:  
 (a) a lien on the item; and  
 (b) the right to retain or sell the item, such sale to be undertaken in accordance with any legislation applicable to the sale or disposal of uncollected goods.
- 20.2 The lien of Pozitive shall continue despite the commencement of proceedings, or judgment for any monies owing to Pozitive having been obtained against the Client.
- 21. Service of Notices**  
 21.1 Any written notice given under this Contract shall be deemed to have been given and received:  
 (a) by handing the notice to the other party, in person;  
 (b) by leaving it at the address of the other party as stated in this Contract;  
 (c) by sending it by registered post to the address of the other party as stated in this Contract;  
 (d) if sent by facsimile transmission to the fax number of the other party as stated in this Contract (if any), on receipt of confirmation of the transmission;  
 (e) if sent by email to the other party's last known email address.
- 21.2 Any notice that is posted shall be deemed to have been served, unless the contrary is shown, at the time when by the ordinary course of post, the notice would have been delivered.
- 22. Trusts**  
 22.1 If the Client at any time upon or subsequent to entering into the Contract is acting in the capacity of trustee of any trust ("Trust") then whether or not Pozitive may have notice of the Trust, the Client covenants with Pozitive as follows:  
 the Contract extends to all rights of indemnity which the Client now or subsequently may have against the Trust and the trust fund;  
 the Client has full and complete power and authority under the Trust to enter into the Contract and the provisions of the Trust do not purport to exclude or take away the right of indemnity of the Client against the Trust or the trust fund. The Client will not release the right of indemnity or commit any breach of trust or be a party to any other action which might prejudice that right of indemnity;  
 the Client will not without consent in writing of Pozitive (Pozitive will not unreasonably withhold consent), cause, permit, or suffer to happen any of the following events:  
 (i) the removal, replacement or retirement of the Client as trustee of the Trust;  
 (ii) any alteration to or variation of the terms of the Trust;  
 (iii) any advancement or distribution of capital of the Trust; or  
 (iv) any resettlement of the trust property.
- 23. General**  
 23.1 The failure by either party to enforce any provision of these terms and conditions shall not be treated as a waiver of that provision, nor shall it affect that party's right to subsequently enforce that provision. If any provision of these terms and conditions shall be invalid, void, illegal or unenforceable the validity, existence, legality and enforceability of the remaining provisions shall not be affected, prejudiced or impaired.
- 23.2 These terms and conditions and any contract to which they apply shall be governed by the laws of New South Wales, the state in which Pozitive has its principal place of business, and are subject to the jurisdiction of the Parramatta Courts in that state.
- 23.3 Subject to clause 14, Pozitive shall be under no liability whatsoever to the Client for any indirect and/or consequential loss and/or expense (including loss of profit) suffered by the Client arising out of a breach by Pozitive of these terms and conditions (alternatively Pozitive's liability shall be limited to damages which under no circumstances shall exceed the Price of the Goods).
- 23.4 Pozitive may licence and/or assign all or any part of its rights and/or obligations under this Contract without the Client's consent.
- 23.5 The Client cannot licence or assign without the written approval of Pozitive.
- 23.6 Pozitive may elect to subcontract out any part of the Services but shall not be relieved from any liability or obligation under this Contract by so doing. Furthermore, the Client agrees and understands that they have no authority to give any instruction to any of Pozitive's sub-contractors without the authority of Pozitive.
- 23.7 The Client agrees that Pozitive may amend their general terms and conditions for subsequent future contracts with the Client by disclosing such to the Client in writing. These changes shall be deemed to take effect from the date on which the Client accepts such changes, or otherwise at such time as the Client makes a further request for Pozitive to provide Services to the Client.
- 23.8 Neither party shall be liable for any default due to any act of God, war, terrorism, strike, lock-out, industrial action, fire, flood, storm or other event beyond the reasonable control of either party.
- 23.9 Both parties warrant that they have the power to enter into this Contract and have obtained all necessary authorisations to allow them to do so, they are not insolvent and that this Contract creates binding and valid legal obligations on them.
