### Pairing (Press for 3 seconds) Bluetooth

Turn on the power switch, hold down  
Fn + 2 / 3 / 4 for three seconds to  
enter pairing mode.

The device will display Multix VIA 1 /  
2 / 3. Press confirm to complete the  
pairing process.

During the process, the LED  
indicator lights (Bluetooth device 1  
red light / Bluetooth device 2 green  
light / Bluetooth device 3 blue light)  
will flash in sequence.
