GENERAL USE DIRECTIONS: Add NanoCharge™ at 0.2 oz per 1,000 ft² (8.7oz per acre) in sufficient water to ensure adequate coverage and mix well before adding other products and applying.

MIXING GUIDELINES: If combining with crop protection or other active ingredients, add the water first (add 0.5-2 gallons of water per 1,000 ft²), then water conditioner (i.e. AMS, pH control), 0.2 oz/1,000 ft² NanoCharge™, pesticide, then surfactant.

STORAGE AND HANDLING: Do not store product in direct sunlight for extended periods of time. Keep container sealed when not in use.

FIRST AID: If inhaled: relocate to fresh air. If skin contact occurs: wash with soap and water. If skin irritation is experienced, consult a doctor.
