**Front Side, Refer to Sample at Right**

- A. Date of sale: day/month/year.
- B. Retailer's name, address, city, state and zip where you purchased the boat.
- C. Model of Boat: Check mark model. Model name is located on the capacity plate on the interior side of transom & on tubes.
- D. Model Year: The last two digits of the Hull Identification Number. For example: 23 = 2023.
- E. Year built: the third number from the last of the Hull identification Number. For example: 3 = 2023
- F. Hull identification number: this number is located on the outside of the boat in the back on the hull. It is a twelve-digit number that begins with FUR.
- G. Length: Check mark length  
i.e. 290 CM = 9' 5" & 330CM = 11'
- H. Propulsion: if your boat has a motor or will be used with a motor check outboard fill in the horsepower (hp) rating of your motor. Otherwise, check manual.
