(Version 3.0 – May 1,2020)



- 1. Audubon Conservation Ranching (ACR) program
 - a. Compliance with required ACR Protocols per schedule in all categories:
 - i. Habitat Management
 - ii. Forage & Feeding
 - iii. Animal Health and Welfare
 - iv. Environmental Sustainability
 - b. Basis per September 2017 documentation (as may be revised over time)
 - c. Copy of initial ACR certificate and Habitat Mgmt Plan provided at time of first supply
- 2. Additional Blue Nest Beef Forage and Feeding protocols
 - a. Both before and after weaning, animal's diet must be derived solely from milk, forage and approved supplements.
 - i. Forage consists of
 - 1. Grass, forage legumes, forbs, browse
 - 2. cereal grains, brassicas and other growing crops in the vegetative state.
 - 3. Any forage listed above made into hay, haylage, baleage, silage
 - 4. Crop residue without grain.
 - 5. Approved non-GMO supplements include only:
 - a. Non-GMO Soybean hulls or soybean pellets or cubes
 - b. Alfalfa and/or grass cubes and pellets (No Roundup Ready alfalfa)
 - c. Apple cider vinegar and cane molasses (No beet molasses)
 - ii. Routine mineral and vitamin supplementation.
 - b. Animals may not be fed grain or grain by-products, or anything contains animal by-products
 - **c.** Animals must have continuous access to pasture until slaughter.
- **3.** Additional Blue Nest Beef Animal Health & Welfare requirements:
 - **a.** Animals must have continuous access to pasture. Exceptions for emergencies that may threaten the safety and well-being of the animals or soil, and management practices such as roundups, sorting, shipping, and weaning are allowed.
 - b. Use only low stress handling methods during weaning, handling, moving, sorting, loading and transport.
