#### Precautionary Statements:

<b>Prevention:</b>	Keep out of reach of children. Read label before use. Wash hands thoroughly after handling. Do not breathe fumes, mist, vapours or spray. Wear protective gloves & eye protection. Keep away from heat, hot surface, sparks, open flames and other ignition sources. No smoking. Keep container tightly closed. Ground, bond container & receiving equipment. Use explosion proof equipment & non sparking tools. Take precautionary measures against static discharge
<b>Response:</b>	IF ON SKIN: Wash with plenty of water. Take off contaminated clothing and wash before re-use. IF IN EYES: Rinse cautiously with water for several minutes. ### 4. FIRST AID MEASURES

<b>Inhalation</b>	Remove the victim from the source of exposure, if rapid recovery does not occur, seek immediate medical attention. If the victim is not breathing, apply artificial resuscitation.
<b>Ingestion</b>	Do NOT induce vomiting. Give water to drink. Seek immediate medical attention. If spontaneous vomiting occurs, keep head below hips to prevent aspiration.
<b>Skin</b>	Remove contaminated clothing and launder before re-use. Wash affected skin with soap and water.
<b>Eye</b>	Hold the eyes open and flush with water for at least 15 minutes. Seek medical attention.
<b>First Aid Facilities</b>	This Safety Data Sheet should be provided to the attending medical doctor. Normal washroom facilities are generally suitable. It is recommended that an eyewash station be available and ready for use.

### 5. FIRE FIGHTING MEASURES

#### Fire Fighting Measures:

Highly flammable liquid

#### Suitable extinguishing media:

Foam, water spray or fog, dry chemical powder or carbon dioxide. Do not use water in a jet.

#### Specific Hazards:

Highly flammable liquid and vapour. May form flammable vapour mixtures with air. Flameproof equipment necessary in area where this chemical is being used. Nearby equipment must be earthed. Electrical requirements for work area should be assessed according to AS3000. Vapour may travel a considerable distance to source of ignition and flash back. Avoid all ignition sources. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke.

#### Hazards from Combustion Products:

Carbon monoxide may be evolved if incomplete combustion occurs. Will float and can be reignited on surface water. Vapour is heavier than air, can spread along ground and distant ignition is possible.

#### Special Protective Equipment for fire fighters:

Wear full protective clothing and self-contained breathing apparatus. Hazchem code 3YE.

### 6. ACCIDENTAL RELEASE MEASURES

#### Spills & Disposal

- For small spill(<1 drum), transfer by mechanical means to a labelled, sealable container for product recovery or safe disposal. Allow any residues to evaporate or use an appropriate absorbent, material and dispose of safely.
- For larger spills (>1 drum), If safe to do so, shut off all possible sources of ignition. Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Use a spark-free shovel. Collect and



seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.

**Personal Precautions, protective equipment & emergency procedures:**

Avoid contact with spilled or released material. Shut off leaks, if possible without personal risks. Isolate hazard area and deny entry to unnecessary or unprotected personnel. Remove all sources of ignition in the surrounding area. Take precautionary measure against static discharge. Ensure electrical continuity by bonding and earthing all equipment.

**Environmental Precautions:**

Use appropriate containment to avoid environmental contamination. Prevent from spreading and entering waterway using sand, earth or other appropriate barriers. Attempt to disperse the vapour or to direct its flow to a safe location for example by using fog sprays. Ventilate contaminated area thoroughly.

## 7. HANDLING AND STORAGE

<b>Handling and Storage</b>	Highly flammable product. Avoid breathing vapours. Handle and open containers with care in a well-ventilated area. Ensure that the workplace is ventilated such that the Occupational Exposure limit is not exceeded. Avoid contact with skin, eyes and clothing. Wash thoroughly after handling. Do not eat, drink or smoke in contaminated areas. Electrostatic charges may be generated during transfer. Electrostatic discharge may cause fire. Ensure electrical continuity by earthing all equipment.
